


throughout the country ... and Jim Thompson, a Club employee, made our association function beautifully from the ground up so we can serve our Members in the best way we know how.

### **Applying for Retirement Online**

Members are encouraged to submit their retirement application 60 days before their retirement date when using LACERS' new Retirement Application Portal (RAP). The RAP is a great asset to LACERS Members that helps to streamline the retirement process. While

the filing period is within 30 to 60 days of your retirement date, starting your application early and submitting it on the first day you can at the 60-day-prior mark, will allow



for a couple of benefits. These include having ample time to discover any complications and address them without having to move your retirement date, as well as ensuring LACERS staff has time to meet your retirement date request.

For example, if your desired retirement date is Dec. 17, 2022, you would aim to submit your retirement application in the portal on Oct. 18, 2022. For more information, please visit lacers.org/applying-retirement.

In 1999, Pete was promoted to Sergeant and assigned to Southwest Division as a Field Supervisor. In 2000, Pete was promoted to Sergeant II and assigned to Internal Affairs South Section.

In 2001

Pete transferred to 77th Division as an Assistant Watch Commander. In 2006 Pete was asked by the then Deputy Chief Charlie Beck to establish Operations South Bureau's Criminal Gang Homicide Group as then Commander Pat Gannon's aide. In 2007 Pete completed his bachelor's degree in criminal justice and was promoted to Lieutenant.

From 2007 to 2012, Pete continued his career as Watch Commander in 77th Division, Olympic Division and Central Division. In 2013, Pete was selected by the Director of Office of Operations to be the Officer in Charge of Central Area's Safer Cities. In 2014, Pete was promoted to Lieutenant II and assigned to Communications Division. In 2015, Pete was selected to the position of Assistant Commanding Officer, Communications Division. Pete has been credited for his interpersonal and management abilities in improving the morale and atmosphere of the largest command within the City.



They are lives worth celebrating, and now lives worth mourning.


In the past six weeks or so, the Club family has lost three whom you might have heard of, might have worked with, or might have been friends with. But they all made a difference in the City and the Club experience.

## REMEMBERING AMERICO GARZA 1924-2022

Americo Garza, a Retired Civil Engineer and local and national pioneer in Hispanic representation in engineering careers, died July 15. He was 97 and served the City for X years.

Americo was an Engineer with the City's Bureau of Engineering when he and other Hispanics, dissatisfied with the difficulties they were experiencing in advancing their careers, formed the Los Angeles City Employees Chicano Association (LACECA). Americo would be President of the organization a decade later. LACECA is dedicated to advancing the employment, educational, economical and social welfare of its members and the Latino community through advocating for equal employment opportunity, promotion professional development and networking.

Two years later, in 1973, Rodrigo Garcia, a fellow Hispanic engineer working for the City, gathered other Hispanic Engineers, including Americo, in his garage in East LA to talk about their career frustrations and how to reach out beyond the City. The group included LACECA members George Esquer, Gill Herrera and Alex Vidaurazaga. From that meeting they created the Society for Hispanic Professional Engineers (SHPE). Americo was the group's first First Vice President. On the first board were Garcia, Esquer, Andres SantaMaria, and Vidaurazaga. Today, the SHPE, a leading national organization for Hispanics in the STEM disciplines, has more than 10,000 members and more than 230 chapters, including at many universities.

After retirement, Americo served on the board of the

A merico Garza was one of the Los Angeles City Employees Chicano Association's (LACECA) founding members. He and three other LA City Engineers got together in 1971 to figure out how they could help each other to be considered for job promotions. They were constantly being bypassed despite having a higher final score on City Eligible Lists. That's the reason LACECA was created on March 10, 1971.

After retirement, he regularly participated in LACECA planning events and recruitment, and providing us his wealth of LACECA knowledge when LACECA spearheaded representing members in getting them equitable pay for bilingual work, grievances and equal representation. I dearly remember Americo and his lovely wife, Ella, attending many of the events LACECA organized when I first started working for the City in 1988.

LACECA is the first minority organization recognized by the City Council Employee Relations Resolution, which motivated other minority City organization to create their own employees associations – the LA Asian-American Employees Association, the Black Employees Association, the LA Filipino Association (LAFACE), the LA Gay and Lesbian Employees Association and the LA Veterans Employees Association (LAVVA), to name a few.

Americo's vision and dedication have enabled many of us to be heard and recognized for our efforts.





## REMEMBERING PHIL ORLAND 1946-2022

Phil Orland – active Club Board Member; Retired, Rec and Parks; US Navy veteran; and former RLACEI Board Member – died Aug. 16. He was 75 and had served the City for 35 years.

Phil managed recreation programs for all ages as Principal Recreation Supervisor for Rec and Parks. He worked for the City from 1975 to 2010.

"Phil began working for the City of Los Angeles in Rec and Parks after serving in Vietnam," his widow, Penny, wrote in a remembrance. "He was a very faithful worker and a great boss. He helped many young workers early in their careers. He could never understand how bosses could be intimidated by smart subordinates. He felt capable workers made him look better and always gave them credit."

In retirement, he joined the Club Board in 2018 and was an active Board Member at the time of his death.

(RLACEI), coordinating educational seminars for Retirees on the Affordable Care Act and financial planning. He also played an important role in promoting LACERS' wellness program, designed to help Retired members enjoy a healthy and active retirement.

He was a board member for the professional organization Men in Leisure Services, raising money to provide training and networking opportunities for those in recreation. The Brea resident was also a board member for the Retired Senior Volunteer Program in Orange County and was an ambassador to the Korean Bell of Friendship Committee.

He volunteered on wellness issues for the College of Health and Human Services at Cal State, Long Beach, and he received the 2015 Alumni C o m m u n i t y Service Award from the school.

Phil served the U.S. Navy aboard the USS Henderson during the Vietnam conflict.

continues. "He made friends easily. After retirement, he would join several nonprofit groups/boards to help the community – RLACEI Retired Los Angeles City Employees; volunteer groups; Orange County senior community outreach; and others. He was always willing to help someone in need.

"Even in the end, Phil did his best to resolve problems. On his last hospital stay, when they insisted on doing many tests, he longed to be home instead. He called and demanded I bring him home, but I said no. About an hour later, the nurse called to inform me that Phil had called 911 from the hospital phone to have the paramedics take him home from the hospital. True Phil ingenious.

# Captain's Log

Traveling with Capt. Michael Barnes, Retired, Harbor

### Plumbing at the Top of the World

The Haleakala Volcano, or, in English, the house of the sun, sits 10,023 feet above sea level and forms more than three-quarters of Maui's 727 square miles. The rest of the island is formed by another volcano, called Mauna Kahalawai.

To reach the crater at the summit, you have to pass through the Haleakala National Park. A long, winding well-maintained road, containing many blind turns, very steep drop-offs without guardrails, and 32 switchbacks, holds the world record for climbing to the highest elevation in the shortest distance, 35 miles.

Sometimes cows and geese cross the highway; watch out for them when the conditions are foggy. The National Park Service has suspended commercial bicycle tours within the park after many fatal bike accidents; they are still a danger on the lower slopes of the highway, especially on blind corners when the cyclists tend to swing wide.

The last place for food or petrol is in Makawao, but there is a clean restroom at the visitor center restrooms halfway up and at the crater car park at the top. It takes about 90 minutes to drive the road without stopping to admire the "moonlike" scenery. The car park in the crater holds only 75 cars, which is not a problem during the daytime, but for romantics wishing to see the sunrise, it is a big problem as you need a reservation; the

Park Ranger allows no last-minute drive-ups at the entrance. (You must book one-to-two months in advance) Note: The sunset is just as magnificent, and not as crowded.


From the summit, when looking down into a massive barren depression, see if you can spot a silversword plant. It grows only here and nowhere else on Earth.

The crater car park is dotted with numerous rare Ahinahina plants and Nene (Hawaiian geese), and can be seen wandering around near the car park restrooms and the steps leading up to the observatory.

Even at this high altitude, plumbers are needed. We watched them, dressed like astronauts, resolving the car park's plumbing problems

For hikers, there are two trails leading into the crater from the summit area – the Halemau'u and Sliding Sands trails. The unusually clear views of the night sky here make Haleakala one of the best places in the United States for amateur astronomy, so bring your binoculars or telescopes. This is also the site of Hawaii's first astronomical research observatory, whose twin 30-foot Keck Observatory telescopes is open to the public only by appointment.

The sun sets at about 5:30 p.m. in the winter and 7 p.m. in the summer, and for early mornings and late evenings visits, I recommend that you bring a sweater or in winter a coat, as flip flops and a tank top, even though fashionable, won't keep you warm as it gets cold and windy at this high






Notice board for the Haleakala Observatory.



altitude. Also, if you plan on stargazing, bringing something to sit on would also be nice. I recommend viewing the stars about an hour after sunset

**Tip:** Buy a senior National Park pass for \$20 from the park warden. It covers the entrance for the whole car, plus it can be used for all the other parks nationwide. Cheers!





### What was your inspiration to take on this project and attempt these enterprising endeavors after retirement?

"I took a course that LACERS Well offered called 'Living a Life of Purpose' with Sean Foy and decided to follow through on that purpose after the class."

Eugene is enjoying retirement and has found his niche to keeping busy and productive as well as looking for solutions to today's social challenges. He wishes everyone "all the best and to stay safe!"

## LACERS Sets New Health Subsidy Amounts

Okay, it might not be the most exciting thing that the LACERS Board does each year, but it is important when the LACERS Board sets the maximum health subsidy amounts. This article will be a summary since the amounts are a little

Michael R. Wilkinson too detailed to explain every situation.

The good news is that our very well-funded health benefits (107 percent funded as of the most recent year) will be providing subsidies that cover most of the premium cost for health coverage for most members. For the upcoming 2023 plan year, 92.4 percent of the medical premium cost is covered by the health subsidy.

Some of the health subsidies are covered by ordinance and some are set by the Board, and these are the maximum subsidies. You may qualify for less depending on your vears of service. The Board approved a maximum medical subsidy of \$1.962.20 for Tier 1 Discretionary and Vested Retired Members under age 65 or enrolled in Medicare Part B only. The Board approved the maximum increase allowable; the dollar increases to the two-party premium for the Kaiser health plan for this group of members. This is also the amount for the Medical Premium Reimbursement Program (MPRP) for members living outside the LACERS health plans' coverage areas.

More good news: The percentage increase to the Kaiser

two-party plan of 4.3 percent was well under the cap under the Los Angeles Administrative Code of 7 percent for the three-year average of other plans. Healthy eating and exercising will encourage general wellness and reduce the cost of our health plans as well.

For members who have Medicare Part A and B for Tier 1 and Tier 3, the maximum subsidy was set at \$494.67. This is also the amount for the MPRP for this group.

The maximum dental subsidy was set at \$43.81 per month, an amount that cannot exceed the amount paid to active City employees. This restriction resulted in a slight decrease to the subsidy.

### Are LACERS Investments Bad for Its Members? PT. 2

Last month I detailed some the issues private equity buyout firms cause in our society. Those issues include, but are not limited to, pursuing profits above care in the healthcare and nursing home industries; outbidding individuals who

want to purchase homes; and buying mobile home parks and dramatically raising rents. Some buyout firms increase profits by eliminating positions and even slashing pensions at the firms they acquire.

With all of those issues regarding buyout firms, it would be reasonable to ask why LACERS invests in them. LACERS, along with most other public pension systems, invests in buyout funds to help the systems meet their assumed investment returns - 7 percent in LACERS case. Investing in these funds has become even more popular in recent years as it has become more difficult for public pension systems to

consistently meet or beat their assumed investment returns without such investments

If LACERS chooses not to invest in buyout funds, other investors will gladly jump on the investment opportunities, as access to these funds often is highly competitive. While not investing in buyout funds may give LACERS a moral high ground, it would make it more difficult for the LACERS Board and staff to ensure a well-funded pension system.

Because investors in buyout funds turn over almost all of the investment control for such funds to the private equity firms, LACERS would not be able to influence the specific investments the firms make. So once LACERS invests, it has extremely little influence.

Even getting a coalition of public pension funds across the country to not invest in private equity buyout funds likely would not work due to sovereign wealth funds and other wealthy investors who would largely fill in the funding gap.

So, what is the solution to help ensure pension funds are not investing in ways that will make the everyday lives of their members worse? We need federal legislation and/or oversight on the acquisitions buyout funds make. This will not be at all easy. Even the small proposed change to the way private equity profit is taxed recently got pulled (again) from proposed federal legislation as the vast profits buyout firms make can pay for an army of lobbyists and huge political contributions.

I hope LACERS can work with some of the state and national organizations to which it belongs to help craft proposed legislation that would help regulate private equity buyout firms. This legislation could help minimize the aspects of these firms that are detrimental to the lives of many Americans, while possibly allowing buyout firms to continue to operate in less problematic ways.







he late Americo Garza was truly an admirable man. If you were lucky enough to meet Americo, you would quickly see why so many people admired him. He was a man of great integrity and character, exuding warmth, friendliness and care. His passion for life was evident in everything he did. He was always willing to help others and make them feel comfortable and included. It was clear that he genuinely cared about people and making the world a better place.

I knew that he loved his family, too, and cherished his family life. The vivid example was the enormous smile on his face (and eyes wide open) when he talked to me about his grandson, Patrick Nanson. And he would talk about him as if it were the first time you heard about Patrick - a Navy Seal - which brought forth great pride for Americo. It was only later that I learned that this soft-spoken man was an engineer for Public Works and a board member for the Retired Los Angeles City Employees Association, Inc. (RLACEI); that he was the former co-founder and president of the Los Angeles City Employees Chicano Association (LACECA); and the co-founder of national Society of Hispanic Professional Engineers. Americo's accomplishments are the stuff of legend. But these accomplishments, as outstanding as they are, were merely reflections of Americo's remarkable character. Americo's life was an example of what it means to be truly diverse, equitable and inclusive. He set a positive tone that inspired others through his work, not just with words but also by being someone who brought people from all walks of life together in common cause for progress.


