At press time, the City Council is trying to figure out how to cut the budget – or raise additional funds – to make up a projected \$155 million shortfall (and counting).

Officials are trying to accomplish this feat without cutting employees or service hours, but final decisions have not been made as of the time *Alive!* is going to press.

Early proposals include employing a hiring freeze and asking some employees to take unpaid furloughs.

DWP — The City's plan for serious green energy production took a major step Jan. 31 as the DWP broke ground on its Pine Tree Wind Project in the Owens Valley.


The wind farm, which will be the largest municipal wind farm in the United States when it opens next year, is expected to reduce greenhouse gases significantly.

"Pine Tree is the start of a new model of clean energy," said the Mayor at ground-

breaking press conference.

When completed next year, the 8,000-acre wind farm will deliver 120 megawatts of wind power to Los Angeles, enough energy to power 56,000 homes.

# Newsbrief

#### **HARBOR HOMELAND SECURITY:**

The Port of Los Angeles will receive more than \$10 million in state homeland security grants to beef up security at the nation's busiest containerport, state officials announced Feb. 14. The grants will fund new training, technology and facilities for the Los Angeles Port Police and other law-enforcement agencies that operate at the Port, enabling them to speed communications and emergency responses, and inspect commercial vehicles more thoroughly.

"Our ports are the lifeblood of our prosperity, and this makes them an obvious target for those who would harm us in this age of terrorism," said Los Angeles Mayor Antonio Villaraigosa. "Protecting this great asset - the largest ports complex in the nation - is a crucial task. This injection of \$10 million in Proposition 1B funds will be used to tighten vehicle inspection operations, expand training for our port police officers, buy improved equipment and implement a resource tracking system to aid first responders in the event of an emergency."

"Our Governor and State Legislature should be commended for moving this security funding process forward in such an expedient manner," said Harbor Executive Director Geraldine Knatz Ph.D. "These are funds we can use to bolster our facilities, training and field operations for the benefit of both San Pedro Bay ports and the myriad of agencies that provide our multi-layered security network.

Matthew Bettenhausen, executive director of the California Office of Homeland Security, who announced the security grants, said Gov. Arnold Schwarzenegger has worked extensively with the State Legislature to increase funding to secure California's ports.

"The threat to our port system is one of the most fundamental challenges we face," Bettenhausen said. "The threat to California's economy is very real if our port system is vulnerable to a terrorist attack.'

The grant money represents the first homeland security funding available from California's Proposition 1B, passed by California voters in November 2006 to improve air quality and goods movement, and enhance the safety and security of the state's transportation system. The Port received the single largest chunk of the \$40 million in total security funding announced Feb. 14.

The projects to be funded at the Port include a new vehicle inspection facility where, among other things, a new X-ray imaging system will be used to examine commercial vehicles bound for the World Cruise Center. Law-enforcement agencies also will benefit from new boat-mooring docks and piers, a mobile air-compressor system for divers, training classes in maritime security and a state-of-the-art system for electronically tracking personnel as they operate at the Port and in surrounding communities.

Here's an allocation breakdown of the \$10,060,000 that the Port will receive from the state's Proposition 1B security funding:

- Commercial vehicle inspection area with X-ray imaging system -- \$3.864 million;
- Electronic "Blue Force" tracking system that will enable command and dispatch centers to see where police cars, boats and other equipment are located at all times -- \$3.375 million;
- Temporary mooring and dock facilities for multi-agency law-enforcement vessels, to facilitate joint agency operations -- \$2.377 million;
- Maritime training for law enforcement --\$450,000.

#### **REINING IN THE PAPARAZZI:**

Councilman Dennis Zine introduced a motion into the City Council Feb. 1 to allow the City to more strictly regulate paparazzi photographers.

Paparazzi are becoming increasingly aggressive in their tactics, posing a clear danger not only to the people they are trying to photograph, but to the general public around them, according to the Councilman's office. Reckless driving is already illegal, but laws must be consistently applied to paparazzi in vehicles and on foot, so there is a clear message that the law applies to everyone. The City respects the press' First Amendment freedoms, but public safety must be paramount. The motion calls for stricter regulations of paparazzi, including a minimum "personal safety zone" of several feet of clear space between paparazzi and the individuals they are photographing, including their vehicles. Vehicles must be given more space as required for safe movement.

# Out of the Ground, a New Police Building

PUBLIC WORKS — Starting sometime after summer 2009, the big building going up between First and Second, and Main and Spring Streets will transfer to its principal occupant, the Los Angeles Police

But right now, approximately halfway toward completion, the new Police Headquarters Building belongs to Public Works and its team of inspectors, making sure that the massive project is being done right and on time.

Jim Littleton is the Senior Construction Inspector in charge.

"This high-profile project is an exciting and unique experience to be a part of," he said as he gave Alive! a progress tour in mid-February of the building, which is growing fast. "The professionalism, dedication and positive outlook from my inspection staff and our Bureau Management help make this a positive experience.

"I feel blessed to have such an impressive team from the City family, the Consultants, and the Contractor's personnel to work with," he said.

"Parker Center is more than 50 years old, as such it lacked many of the modern systems required for efficient operations," Julie Sauter, Project Manager, Public Works, told Alive! "The LAPD has grown over these past 50 years.

"More than 30 community meetings and workshops were held during the design phase of this project, which resulted in such features as a one-acre green space on Second Street, a café and retail space, and a public auditorium."

The building is estimated to be complete in Summer 2009.

On Jan. 22, 2007, ground was broken for the project, which had been in the planning stages for years. Present at that ceremony were Chief William Bratton, Mayor Antonio Villaraigosa, Councilmembers Tom LaBonge, Eric Garcetti, Jan Perry, Jack Weiss, Wendy Greuel, Dennis Zine, Greig Smith and Police Commissioner Andrea Sheridan Ordin.

The project will have three components. The first will consist of a ten-story 500,000-square-foot main building with underground parking for 350 vehicles. The second will be a vehicle maintenance facility and parking garage on Main Street between Second and Third Streets. This separate 300,000-square-foot facility will provide parking for approximately 800 vehicles, a mechanic garage, a fueling station and office space for Motor Transport Division personnel. The third and final component will be a public plaza with underground parking for approximately 300 vehicles at First and Judge John Aliso St.


The new police facility will replace Parker Center, which was built in 1955. Parker Center is roughly half the size of the facility under

"This new police facility will bring us into the 21st century," Chief Bratton said. "As society and advancements in technology change, so to must we as a police department. This state-of-the-art facility will enable us to do just that."

The cost of the all three components combined is estimated at \$396.9 million.

#### The Design

The building site is directly south of City Hall, to the east of the Los Angeles Times Building and west of the new Caltrans District 7 headquarters and its associated plaza space.

The structure proposed for the new PAB is a ten-story building with two levels below ground. The first two levels of the building contain the public entrance lobby, conference facilities, cafeteria, fitness center and Police Commission hearing room and offices. The remainder of the floors is for police administrative operations. Also located at grade is an auditorium facility intended to support the needs of the LAPD as well as other City and community functions. A helipad is located on the roof.

The urban and architectural design approaches to the PAB have been driven by the goal of responding to the community, addressing the importance of the site location and the requirements of LAPD. The design has evolved from its initial state through refinements made by the design team, LAPD, Public Works/Engineering, City family, as well as reviews, comments and collaborations with other stakeholders including the City Council; offices of the Mayor, CAO and CLA; and the community.

#### Site Issues

The important location of the site makes it imperative to consider a number of conditions of the surrounding context and to respond to each in an appropriate way. Most obvious of these conditions is the relationship of the site to City Hall and the South Lawn. As the City's seat of government, a strong complimentary response is merited. Several other structures adjacent to the site deserve consideration in the planning of the block, in particular, the south tower of the Los Angeles Times complex and historic St. Vibiana's, and Caltrans' new headquarters.

#### **Urban Design Approach**

One important aspect of the urban design approach to the site has been to create a series of exterior public open spaces, each specifically scaled and designed to complement their respective context. One of these spaces, a civic plaza, is planned along First Street in response to the open space of City Hall's South Lawn. Within this space, areas have been planned to accommodate an existing Police memorial and capable of meeting the needs of Police ceremonies. The portion of this space directly adjacent to First Street is designed to accommodate the regularly occurring rallies and protests at the existing Parker Center. The auditorium, an integral part of the plaza design, has been located at the corner of First and Main Streets to help activate and define this space. This auditorium will be available for LAPD, City and public use and will be the location of one of the PAB art pieces.

The design's second major space is the community park that is planned along the length of the site's Second Street frontage. This space, almost one acre in size, provides a landscaped open space for public use and supports the pedestrian activity of Second Street. Besides being a useful amenity, this space recognizes the south tower of the Times building and results in increased light and air for all buildings surrounding the southern end of the site. Pedestrians will be able to move freely through the site. From north to south, the series of spaces create connections across the site

and beyond, linking the open space of the civic center mall, to the north, across the site to St. Vibiana's and the corner of Main and Second Streets to the south.

#### **Architectural Design Approach**

The massing of the building supports the urban design approach, the goal to provide efficient and flexible floor plans and the desire to achieve an architectural character appropriate for a civic building and the LAPD. The typical floor plan of the PAB is an efficient and flexible L-shape. The placement of the building core functions and the width of the respective legs of the "L" have been planned to create a healthy work environment in a cost-effective manner.

The composition of various types and patterns of glass that make up the exterior of the building and the sheer glass wall that allows clear views in and out of the building to and from the internal circulation spine of the building support the desire of the LAPD to give the building a sense of transparency, yet without compromising the safety of officers and employees working within the building. The triangular form is composed of pre-cast concrete, light in color, yet with a sense of mass and permanence and therefore in keeping with City Hall and many of the other civic buildings north of First Street.





# Bringing Back BROADWAY

#### ■ Councilman José Huizar announces grand plans to renovate the Broadway theatre district downtown, revitalizing the area where many City Employees work and play.

COUNCIL - On Jan. 28, City Councilmember José Huizar, joined by Mayor Antonio Villaraigosa and property owners of the largest theater district west of the Mississippi, unveiled a vision for Bringing Back Broadway and announced an initial \$36.5 million investment for projects that will restore downtown's historic Broadway District to its former glory.

The district, in the heart of downtown, is also heavily populated with offices of the City, where many City Employees work and socialize.

"All great cities have a bustling theater district-London, New York, and Paris would not be the cities they are today if their theater districts, and all the great things to do nearby the theaters, did not exist as the cultural hearts of those cities," Councilmember José Huizar said during a news conference at the Los Angeles Theater. "Now is the time for Los Angeles' cultural heart to beat again on Broadway."

Bringing Back Broadway is a public-private partnership between Councilmember Huizar's office, the Mayor's office, the City and owners of properties on Broadway. For the initial phase of the initiative, Councilmember Huizar has identified more than \$16.5 million in City, state and federal resources to help pay for streetscape design, property for a new parking facility, and the next steps in the streetcar revival plan.

"Bringing Back Broadway complements the dynamic revitalization efforts that are transforming downtown Los Angeles into a world-class destination," the Mayor said. "A restored Broadway District will keep Los Angeles rooted in history as we grow into our future."

Property owners committed to invest more than \$20 million for façade lighting and improvement, historic rehabilitation, business improvement district activities and state-of-the-art technical upgrades.

"Bringing Back Broadway is a long-range

vision and a passion project for everyone involved," Huizar said. "This is just the beginning. We will see great progress this year and over the next several years, with a decade of work before us to make Broadway revitalization a reality to benefit our entire City. It's a great feeling to get things started and see the opportunities ahead."

Huizar envisions a Broadway that harkens back to its glory days, while providing entertainment, eclectic cultural amenities and diverse retail options for downtown residents and visitors enjoying one of the city's most remarkable pieces of history.

The Bringing Back Broadway initiative will link Broadway's past to its future. The City is studying the feasibility of reviving the downtown streetcar. The streetcar served as a popular mode of transportation along Broadway until 1961. The revived downtown streetcar would connect the revitalized Broadway district to new, large-scale downtown developments, such as L.A. Live and the Grand Avenue project.


Under the plan, private investments, such as property rehabilitation and technical upgrades necessary to sustain programming, will be made while the City improves the public way, increases parking and focuses on transit connectivity with the streetcar.

Before Hollywood became the worldwide center for the entertainment industry known today, Broadway was the birthplace. Vaudeville acts and early century cabarets found great success inside the ornate theaters that lined Broadway. The Marx Brothers performed on Broadway, and many of our nation's greatest entertainers - Bing Crosby, Bob Hope, Jack Benny and George Burns - honed their craft on Broadway. Later, the theaters evolved into the grandest of movie palaces. Charlie Chaplin premiered "City Lights" at the Los Angeles Theatre, and Broadway was the launching pad for numerous Hollywood stars and starlets on the silver screen.

"Broadway holds just as important a role in shaping our City's main business into what it is today as El Pueblo's Olvera Street, known as the birthplace of Los Angeles, played in forming our cultural destiny," Huizar said.

"The Broadway of tomorrow will be a strolling boulevard that offers a wide variety of options concerts, plays, musicals, sidewalk dining, shopping and others services - to meet the desires of current Broadway retail patrons, and our growing and diverse Downtown community," Huizar said. "There will truly be something for everyone on Broadway, day and night."





■ DWP breaks ground on the largest cityowned wind farm in the **United States.** 

DWP — Delivering on a goal that the DWP outlined in Alive! last October, the department and City leaders broke ground Jan. 31 on a massive wind farm in the Owens Valley.

The department's Pine Tree Wind Project will be the largest city-owned wind farm in the United States, according to the DWP.

When completed next year, the 8,000-acre wind farm will deliver 120 megawatts of wind power to Los Angeles, enough energy to power 56,000 homes.

The clean energy produced by Pine Tree will also displace at least 200,000 tons of greenhouse gas emissions, the equivalent of taking 35,000 cars off the road. It will also cut eight tons of nitrous oxide and 11 tons of carbon monoxide.

"Pine Tree is the start of a new model of clean energy, in which the City of Los Angeles is no longer satisfied with only buying clean power, but is taking the lead nationally in producing its own," Mayor Villaraigosa said.

The mayor also announced plans to develop the Pine Canyon Wind Project on 12,000 acres of adjacent property recently purchased by the DWP. The 150-megawatt wind farm will surpass Pine Tree as the largest wind farm in the United States by an output of 25 percent.

Located in the rugged Tehachapi Mountains within sight of the first aqueduct to feed water to the City, Pine Tree is unique in that it will be the largest municipally owned and operated wind farm in the nation. By comparison, the second largest City-owned farm -- Sacramento Municipal Utility District's Solano County project -- outsources its operations to a third party.

Pine Tree's energy will come from 80 1.5megawatt wind turbine generators, a new highvoltage transmission line and the new Barren Ridge electrical substation, at a total estimated





The project's construction will generate hundreds of green contract jobs, in addition to the dozen full-time jobs for the farm's long-term maintenance, according to the DWP.

"The Pine Tree Wind project speaks volumes about our commitment to renewable, clean energy," said Councilwoman and Club Member Jan Perry, Chair of the City Council's Energy Environment and Committee. "Through innovative and creative programs like this, I am confident that we will be able to reduce our carbon emissions and reach our goal of 20 percent renewable energy by 2010."

Since 2005, the City has nearly tripled its current renewables portfolio (from three percent) while approving numerous projects now in the pipeline that will come online by 2010.























# In With the New it LA

AIRPORTS — A little over a year ago, Airports established a new Construction Division. Superintendent India Griffin hired us -- Gary Arso and Carlos Gomez, both Construction and Maintenance Supervisors Level 2 -- to manage this section. Although the Construction Division has been busy during 2007 with many projects throughout the airport, the primary focus has been

on Terminals 1 and 6, which are part of the CTA (Central Terminal Area) Rehabilitation Program.

During the past 12 months at Terminal 1, nearly 40,000 square feet of carpet was replaced; more than 16,000 square feet of travertine was honed and polished; and more than 60,000 square feet of ceiling tile was replaced. The construction crews have been extremely busy at Terminals 1 and 6 repairing, replacing or adding plumbing lines, plumbing fixtures, air conditioning ducts, flooring (both ceramic and carpet), lighting, painting and remodeling the men and women's restrooms. When we talk about remodeling a restroom, we are talking about completely demolishing the old and starting from the ground up. The Construction crew makes safety its number one priority, followed very closely by hitting the set deadline.

The first phase of remodeling a set of restrooms was the demolition. Foreman Adan Gonzalez and his demolition crew started by removing the existing partitions, walls and ceilings, and they busted out the floor by using several jackhammers. The demolition crew can usually complete this part of the job in about a week. It is amazing to see how rapidly this crew can go into demolition mode and have everything hauled out in such a short period of time.

Hauling the material out was one step, but hauling the material away was another project in itself. The Construction Division depended very heavily on the assistance of Airports' recycling section, run by Superintendent Thomas McHugh and Airport Maintenance Supervisor Dave Takemoto. During the demolition phase, it was not uncommon to have a 40-yard trash bin hauled out full every day.

After the demolition was completed, the plumbers came in and removed the old fixtures. All the restrooms needed to have the old sewer lines replaced: this was accomplished by using a jackhammer to break up the concrete to expose the old lines, and replace them with new castiron lines. Plumbing Foreman Robert Bustamante and his crew also replaced the hot and cold water lines, installed new valves, and replaced fire sprinklers. The urinals, toilets and sinks were replaced with automated valves and

low water consumption fixtures.

Airports construction crews also relied on the assistance of Plumber Supervisor Hart Brauer and his crew. Hart knows the plumbing system better than anyone at LAX, and his expertise on knowing what valves to shut off or what model of a fixture to use made the Construction Section's job run very smoothly.

Carpenter Foreman Marty Morton and his crew were responsible for framing the restrooms as per the blue prints. The crew removed the old studs and replaced them with new ones, added backing for partitions and counter tops, and framed openings for items including baby changing stations, trash receptacles and automated paper towel dispensers. After they set the tile, they installed all the accessories and made sure everything was ADA-compliant. Bill Vasquez, Senior Carpenter, was a key element in assisting the newly formed Construction Division. When the Construction Division first started out, he was our go-to guy because he knows who all the vendors are and where everything is, and the operational practices used at LAX. Billy assisted us in getting material on short notice and went above and beyond what anyone could expect.

Kirk Nelson, Electrical Foreman, and his crew had the task of installing several conduit runs to

supply power to all the automated fixtures. The

electricians also replaced the old lighting with new energy efficient lighting systems. Instrument Shop Supervisor John Dever worked very closely with the Construction Division electricians in installing as well as having the Fire Life and Safety strobes tested and inspected.

Construction Paint Foreman Robert Louis and his crew were responsible for taping all the joints, and laying down the primer and finish coats of paint. The paint crew took tremendous pride in the work that they accomplished, and it shows in their quality of work. Paint Supervisor Michael D'Avirro was very beneficial in assisting the Construction Divisions painters. Mike and his staff helped in correctly identifying the standard colors used at LAX, which was a tremendous help to the Construction Division.

Airports Construction Division is very fortunate to have three fantastic Tile Setters -- Jose Franco, Florenzo Casarez and Martin Patin, who were assisted by a core of helpers who prepare

the walls and floors for the new ceramic tile. The tile setters and helpers had a very grueling task. On average, each set of restrooms uses 300 94pound sacks of "mud." This "mud" had to be mixed and hauled to each restroom via a wheelbarrow. It took about four weeks to complete the tile installation.

On any given day, the amount of materials ordered for these projects to run smooth was pretty incredible. We could not meet the deadlines if not for the support we received from our Purchasing Department. Gwynn Menefield, Graciela Almada, and Patreasea Buckley assisted in generating all the paperwork needed to keep us running smoothly.

It took a complete team effort for the Construction Division to succeed, and we would like to thank everyone here at LAX for allowing us to be part of the Airports family.



# Marchivist (Retired), and Club Member **Tales From the City Archives**

#### ■ Third in an occasional series of historic bridges and viaducts in the City.

The Los Angeles River Bridges Recording Project team documented 15 historic bridges in the City. Twelve of the bridges cross the Los Angeles River. Two others span deep ravines, and a third is an important grade separation. Built between 1909 and 1934, the river bridges group contains many of the finest examples of City Beautiful bridges and viaducts in the United States.


This system of bridges and viaducts has played a crucial role in the development of the Los Angeles metropolitan area. Key elements in the establishment of traffic and settlement patterns, the structures allowed people to move themselves and goods across land and water barriers and promoted the successful establishment of commercial and residential areas.

Through the use of the reinforced concrete arch, bridge builders harmonized architectural beauty and structural integrity, creating structures that unified the city and created pride in its public works.

On June 5, 1990, following the Oct. 17, 1989 Loma Prieta earthquake in Northern California, the voters in the City of Los Angeles passed Proposition G, a \$376 million seismic bond issue that included \$78 million for the retrofit of the Los Angeles River bridges. Over the last decade, Public Works/Engineering has seismically retrofitted those bridges. All of the bridges have been rehabilitated in keeping with their historical architectural character. The retrofit and restoration of the fifteen bridges is as much an outstanding engineering achievement as their original design.


The Olympic Boulevard Viaduct was one of these projects. But this construction site has an interesting history. It was built in 1925 and originally called the Ninth Street Viaduct, which in time was changed to the Olympic Boulevard Viaduct as part of the name change of Tenth Street to Olympic Boulevard in 1930, honoring the 10th modern Olympics, held in Los Angeles in 1932.

Olympic Boulevard has always been a major City artery that connected Boyle Heights in the east, downtown and the Westside of Los Angeles. Originally trolleys ran on the middle of the bridge in both directions.

#### ■ Club Member and expert **Emily Gutierrez sheds light** on the job interview process.

Over the past few years, I have interviewed many candidates for entry-level positions and jobs that have the potential for supervision, and I have noted an alarming trend. In short, most of the interviews were dismal and dismaying, as well as hopeful and heartening. I was very disappointed by the poor showings of people who are already in the Civil Service system; conversely, I was quite impressed by those coming in from outside of the system. The candidates who showed up for the interviews completely unprepared were quite noticeable, as were those who prepared. Most people are blissfully unaware of the consequences of a lack of preparation. Therefore, I have condensed the results of my observations, as well as the observations of my cointerviewers, and submit the following recommendations so that candidates can make sure the loss of a potentially great job does not happen to you.

- **1.** *Don't* show up for the interview late. *Do* give yourself ample time to arrive early (no more than 15 minutes early).
- 2. Don't dress for the interview like you're going to a nightclub or doing some gardening. Do try to dress like you care about the job for which you are interviewing.
- **3.** *Don't* wear loud prints and colors or splashy ties; do tone it down. Plan your outfit in advance; get a second opinion, and even a third.
- **4.** Don't wear strong perfume or cologne; in fact, don't wear any scent. Do make sure you do not smell of anything stronger than soap. Many people have allergies to cosmetics scents. Being trapped in a small room with someone who reeks can cause an interviewer to subconsciously score you on the low end or rush you through the interview, just to escape the odor.
- 5. Don't overdo the makeup, hair, jewelry and accessories; remember, less is more. Do remove all but the simplest jewelry; limit yourself to one ring. Hair should be clean, neat, combed, and conservatively styled. Stay away from hair color that doesn't appear in natural hair; no spiky pink Mohawks, please.
- 6. Don't let your piercing(s) or tattoo(s) speak for you. I understand that body art and piercing is a matter of self-expression; however, as an interviewer and potential employer, I am not interested in how you feel about whatever your issue is. These are unnecessary distractions for the interviewer and can leave a potential employer with discomfort, which translates very easily to a lower score. Do make an effort to disguise and/or cover your artwork.
- **7.** *Don't* answer interview questions off the top of your head. Do some preparation. I recommend having a friend ask you three typical interview questions and record your responses. More importantly, listen carefully to your responses and have your friend critique them; take notes. Afterward, answer and record the same three questions again and repeat the process until you are satisfied.

- 8. Don't let your résumé go past a single page. Do pare it down and keep it relevant to the job. Research résumé preparation and construct it carefully. Keep in mind that your résumé will speak for you before you arrive.
- 9. Don't list your employment experience chronologically; oftentimes, this information can be redundant. Do condense your experience and use bullet points to point up experience relevant to the position.
- 10. Don't come to an interview without doing some advance work. Do research the department/division/section where your interview is; talk to someone who works there; ask questions. Go online and read about the Department; find out what the mission statement is, and keep it in mind. If you have an opportunity to segue the Department's mission statement into your response, do so but only do so once.

There are many more helpful hints that come to mind but, just like a good interview candidate, I decided to limit myself. Striking a balance between giving a thorough answer and telling a long (and tedious) story is a tricky business. Recording and listening to your responses with a critical ear can be a real "aha!" moment. You catch yourself rambling and imparting useless information and vou can't seem to find your way out of the situation; that's when panic can set in. When this happens, take a deep breath and relax. The interviewers know that any interview comes with a certain level of nervousness and take that into account when scoring.

The content of your responses is the most important aspect of your interview. The information you impart should be brief and to the point. Introducing an answer with a seemingly pointless and irrelevant explanation can cause a lot of frustration for the interview board. I have often had to "reel in" the candidates and bring them back to the question at hand. I once heard someone speak of a poor interviewee as follows: "If you ask him what time it is, he tells you how to build a watch." Don't be a watch-builder.

Please keep in mind that a job interview is not an opportunity for you to show off your stand-up comic abilities. Although an interview is serious business, any time you can lighten things up using self-deprecating humor can help you and the board relax and the interview will go smoothly. Again, this is tricky business and I would try it out on a friend before I brought comedy into an interview.

Interviewers will often ask a candidate to relate an experience to illustrate their answer. It is not necessary to give the interviews a history of your world. Use your most recent experiences to illustrate your answer; keep it brief and keep in interesting (more tricky business).

If you follow these basic rules, and any other do's and don't's you can think of, your success may not be guaranteed, but you will stand a much better chance of getting that really great job you've been searching for, and your employer will be getting someone that demonstrates that their professionalism is of paramount importance.

# Newsbrief

#### **RECORD-BREAKING BOAT TOURS:**

As reported by the Harbor Jan. 30, during 2007, 11,471 fifth-grade students from 125 schools participated in the Port's School Boat Tour Program a 24 percent increase in school participation and an 11 percent increase in student participation over 2006, a new record for the 11-year-old program, which was created in cooperation with the Los Angeles Unified School District. The tours are provided free of charge by the Port as well as a subsidy for bus transportation.

In addition to the school program, the Port hosted boat tours for more than 16,700 visitors from business and community groups during 2007, including an estimated 9,800 visitors during the World Trade Week free boat tours last May. This year, the Port's World Trade Week free boat tours will be offered May 17 -18.

In 2007, 139 classes took boat tours over a 41week period. Schools from the San Fernando Valley -- including Woodland Hills, Reseda, Northridge and Sylmar -- accounted for nearly 10 percent of the total number of tours. The Port's Speakers Bureau conducted more than 40 elementary school classroom visits to prepare students for their boat tour experience, a 62 percent increase over 2006. Students participated in the program as a complement to their LAUSD local history curriculum.

"Our students were thoroughly interested in the entire tour! The tour really tied into our study of California and geography. Great links to economics as well. The tour combined many facts as well as a boating experience my students had not had before. This was a terrific experience!" said J. Keppel, a teacher at Cold Water Canyon Elementary School.

With a narrated 55-minute boat tour departing from Ports O' Call Village in San Pedro, the Port's School Boat Tour Program provides a unique, up-close opportunity for youths to see the daily operations of the nation's leading container port. For younger students, the Port arranged rides on its Waterfront Red Car Line to provide a transportation adventure of days gone by when the red cars ruled the Southern California transportation system.

The School Boat Tour Program has grown in popularity as teachers have discovered that the tours add real value to their classroom curriculum. Teachers have also found that the tours bring to life the concept and scale of global trade as students see shipping containers being loaded and unloaded from massive cargo ships by giant cranes. Students also experience the diversity of operations within the Port, as well as a myriad of places of interest.



# The Year of the Rat

#### ■ Three City Departments welcome the Chinese New Year.

One function that all City departments share is our commitment to public service. Sometimes public service means educating the public, furthering cultural exchange and understanding, and stimulating the local economy. In February, three City departments did these things by celebrating the Chinese Lunar New Year.

Chinese New Year began Feb. 7.

The Chinese zodiac dates back to 2,600 BC and is based on lunar cycles, which means the starting date of each year varies between late January and mid-February. Lunar year 4706 began on Feb. 7. This year is the Year of the Rat, the beginning of the zodiac cycle of the 12 venerable beasts.



#### Library

On Feb. 2, Senior Librarian Madeline Bryant and Librarian Joanna Fabicon performed a storytelling program titled

"Groundhog Presents Year of the Rat" at the Los Angeles Central Library. Madeline is one of five librarians in the Children's Literature Department who designs and implements the storytelling program from 2 to 3 p.m. every Saturday. The program for Feb. 2 incorporated a variety of Groundhog Day stories and Chinese Lunar New Year stories. One such story Madeline brought to life was Cat and the Rat by Ed Young, a story on the origin of the order of the Chinese zodiac and why the cat and the rat are enemies to this day.

The program filled all 63 seats with children and their parents.

> "It is hard to find a story short enough on Chinese New Year to read aloud" Madeline

"We try not to put an age group on our children's program," she continued. The librarians plan the programs with some short, simple picture books and some longer, more involved stories so to appeal to a variety of children's ages. This way, parents are reminded to read aloud to their children beyond the pre-reading age. She recommends Jim Trelease's The Read

Aloud Handbook as an excellent resource for parents and caregivers who want to share the gift of reading with children.

Librarian Wanda Fong of the Chinatown Branch Library juggled even more activities during February. From Feb. 1 to 23, she told Chinese New Year stories, hosted a Chinese calligraphy demonstration, and invited Miss Chinatown and her court for a visit.

'Usually, we have a Chinese knotting and Chinese lantern making program to celebrate the Chinese New Year," Wanda said. She has been with the Chinatown Library since the grand opening in February 1997.

"I think the children are really lucky to celebrate Chinese New Year," Wanda continued. "It is a joyous and festive holiday for them -- they receive 'lai see' [lucky red envelopes)]. As my children were growing, they were very anxious to see the 'Grand Dragon New Year's Parade.' That tradition still continues today. It is also a time for family gatherings -- good food (the preparation of the food) and fellowship," she said.

#### Zoo

The Los Angeles Zoo celebrated the Chinese Lunar New Year on Feb. 9 and 10 with martial arts demonstrations, Asian foods, festive music and a special educational program on rodents. Gina Dartt, the Zoo's Promotions Coordinator for the last seven years, took two months to prepare for the weekend event that drew more than 24,000 visitors over two days. That's a record breaker over the usual 8,000 visitors per day. The Chinese Lunar New Year is one of eight celebrations, including Black History Month and Reindeer Romp, that she prepares annually.

Gina, who is familiar with all 12 animals of the Chinese zodiac, said, "We try to highlight and work in the animal of the year into our educational program.


"I was glad that we found five rodents, including the guinea pig and the prairie dog, to join the program," she said. "These are animals that visitors would otherwise miss out on [during a regular visit]."



El Pueblo de Los Angeles Historical Monument is not only the birthplace of the City of Los Angeles, but also the home to the Chinese American Museum. This historical traditional site of Los Angeles' first Chinatown has hosted the Lantern Festival since 2001. This year's festival took place Feb. 23. All activities were free to the public; the Lantern Festival traditionally marks the official closing of the Lunar New Year period, which lasts 15 days.

The one-day festival includes family-oriented programs including stage performances, art workshops on Chinese lantern making, children's workshops and water coloring demonstrations.

The festival has customarily drawn more than 12,000 event participants every year. This year, book signings by two popular Chinese American authors added a special touch to the educational program. Award-winning author Icy Smith, along with the book's illustrator, Gayle Garner Roski, debuted her first children's book, Mei Ling in China City, based on an 80-year-old woman's experience in Los Angeles' "China City" during World War II. In celebration of this year's astrological animal and the qualities of those born under this sign,

#### **Teen Dating Violence**

In addition, according to a recent report from the Journal of the American Medical Association, approximately one in five female students report being abused by a dating partner. The Topline Findings: Teen Relationship Abuse Survey, conducted by Liz Claiborne, Inc. in March 2006, shows that a significant number of teens are not only victims of dating abuse but are accepting it as normal behavior. The survey goes on to say that as teens grow older and enter into more serious relationships, they exhibit acceptance of controlling, abusive and even violent behaviors over younger teens who've had less dating experiences.

This half-hour show combines three different stories; each portrays different types of teen dating violence issues including verbal, emotional and physical abuse. The three stories are set in a high school atmosphere and are interlinked. At the conclusion, the viewer is left open to discuss what those issues are and how they can be resolved.



Do you consider yourself a pretty good mountain biker? Do you think you have a pretty good mountain bike? If you want to test both your biking skills and the toughness of your mountain bike, do what I did: Ride the Gabrielino Trail from Switzer's Campground to the Jet Propulsion Laboratory (JPL) in La Cañada Flintridge. I guarantee you, when you are finished you will not only be at one with your bike, but you will feel an overwhelming sense of accomplishment. And hey, if you aren't an avid mountain biker, this trail makes a great hike as well.

Gabrielino

The Switzer picnic area is named for Commodore Perry Switzer. With Bob and Elizabeth Waterman, he began Switzer's Camp, one mile down the Arroyo Seco, in 1884. That camp was accessed only by hiking up from Pasadena across 60 stream crossings!



At 1.28 miles, you'll come to this sign. Bear to the right crossing the stream and going up a steep switchback Continue up the trail for a half-mile and be very careful -- the canyons are extremely steep.



At 1.62 miles, you'll come to a fork in the trail. This is a good place for a break. Bear right.

I did this ride as a shuttle ride; that's where you and a buddy leave one car at the parking lot near JPL and drive the other car with your bikes up to Switzer campground. When you're done, you drive yourself, your bikes and your buddy back to your car at Switzer's to pick up your second car. That allows you to make a one-way trip, and not have to trek all the way back to get back to your car.





Getting to Switzer's Campground:

From the 210 Freeway, take the Angeles Crest Highway exit (also known as the 2 Highway). Go north. Reset your trip odometer because the turnoff to the campground will be almost exactly 10 miles up Angeles Crest Highway (the sign for Switzer's was knocked down when we visited, so unless you set your odometer you may have trouble

finding it). Just shy of 10 miles, you will see this sign. Keep Palmidal. going toward Mt. Wilson. About a quarter of a mile past this sign, keep your eye out for a turnoff on the right. This is the entrance to Switzer's Campground (mile marker 34.2). You can either park up off the highway or go past the big pipe gate down to the campground. If you go past the pipe gate, make sure you know you're going to be back before 4:30 p.m., because that's when they lock the gate. (This ride can take from three to five hours.)

Parking near JPL:

From the 210 Freeway, exit at the Windsor/Arroyo exit. Go north for about a mile and park in the paved lot at the left. The trail starts just past this parking lot beyond the big pipe gate.

 ${\tt GENERAL\ SERVICES--On\ Jan.\ 16,\ Emergency}$ Preparedness' BEEP Program (Building Emergency Education Program) honored five excellent General Managers/division leaders for their dedication to the important preparedness program.

The five given certificates of appreciation were Alvin Blain, General Services; Margaret Whelan, Personnel; John Lewis, Zoo; John Reamer Jr., Public Works/Contract Administration; and Jon Kirk Mukri, Rec and Parks.

The honors were presented by both co-chairs of the Fire Life Safety Subcommittee (FLSS): Richard Wuerth, BEEP Program Director and Jeff Elder, Fire Captain II. FLSS is a subcommittee of the Emergency Management Committee. Also presenting was Armando Hogan, Fire Captain II, representing City of Los Angeles Fire

Chief Douglas Barry. BEEP creates emergency plans, schedules trainings, creates safe refuge areas and facilitates evacuation drills for City

Some General Managers have made the BEEP training mandatory for all of their employees.

In response to concerns arising from the 1987 Whittier earthquake, in January 1989, the Emergency Operations Board (EOB) approved the Building Emergency Coordinator Program (BEC) now known as the Building Emergency Education Program (BEEP). In September 1989, the City Council approved a City Administrative Office (CAO) report recommending that General Services implement the BEC Program. General Services is responsible for the overall operation of the program, and works with the Fire Department (LAFD), which is mainly responsible for BEC, Floor Warden and Emergency Response Team training and the review and approval of building emergency procedures manuals and building emergency signage.

The BEEP Program is designed to provide proper coordination of emergency training, planning and response in City facilities (owned or leased) occupied by ten or more City employees. Building Emergency Coordinators (BECs) are responsible for the preparation and maintenance of emergency plans; training for building evacuation and re-entry; supervision of Floor Wardens and City Emergency Response Teams; damage assessment observation; and decisions regarding evacuations and re-entry of the building after a disaster. The program is divided into three phases by the significance of service rendered to the community.

The Program is in phases I and II and well into phase III. Phase I and II have designated Building Emergency Coordinators, Floor Wardens and other building emergency responders (building emergency response teams). Phase I is also known as the "Big Eleven," which consists of 11 major City facilities. Phase II includes the next 35 significantly important City-owned and leased facilities. Phase III has added 84 City facilities in the last 3 years and is working on adding another 220 + buildings meeting the program criteria and will involve requests to department heads to designate BEC's and schedule Fire Life Safety training for these facilities.

Congratulations to the honorees, and thanks to Richard Wuerth, Emergency Preparedness Coordinator 1, General Services, for his assistance.



# Be Ready When The Weather upns

This time of year, Californians are dealing with weather conditions that can change very rapidly. This could endanger your safety whether at home or on the road.

Here are some tips to be prepared ahead of time for severe weather, and to deal with it when it comes.

- Plan for bad weather before it arrives by storing emergency supplies including flashlights, water, bedding, radio, medical supplies, shovels, plastic, tape, and gloves.
- Never drive or wade across moving or run-
- Never leave children unattended during flooding or severe weather.
- Be careful of high tide warning. (Never turn your back to the ocean.) Drowning is the number one cause of flood deaths.
- Teach children *not* to play or ride bikes near deep puddles or flood control channels.
- If you see someone in the water, call for help. Don't jump in and become a victim.
- Stay away from downed power lines and electrical wires.
- Call 9-1-1 to report all emergencies.
- Have sandbags, hand tools and plywood ready for use if you live in the canyons, hills or areas that are prone to flooding.
- In the City of L.A., you can get sand bags at your local fire station.
- If the weather forecaster calls for a chance of flooding, make sure you listen to a radio or television station for updates.
- If you are told to evacuate, do not wait. Evacuate the area immediately.
- Do not forget your pets. Have leashes, crates, food and identification for them.
- Be sure your entire family knows were your emergency meeting place is.

- Take photographs of important objects and documents for insurance purposes.
- During a power outage, have flashlights available. Never use candles.
- Never use a hibachi, barbeque or cooking stove indoors for heating or cooking.
- Keep family and emergency telephone numbers available. Keep cell phones charged.


# Thanks to the Volunteers

FIRE DEPT. — The men and women of the Fire Department welcomed Mayor Antonio Villaraigosa, Councilmember Bill Rosendahl, Fire Commissioners, Fire Chief Douglas Barry, City Engineer Gary Lee Moore and civic and community leaders at the public dedication and grand opening of LAFD's new Neighborhood Fire Station in Mar Vista on Jan. 5.

The new facility is at 1970 Venice Blvd. in West L.A.

Following Saturday's dedication ceremony, there was food and fun as well as a chance to tour the new station. All members of the community were welcome at this family-themed public event.

The facility it replaced was built in 1950. Built in the days preceding the Korean War to serve a then lightly populated and primarily residential six-square-mile district of ocean view homes, former Fire Station 62 was designed to house a small cadre of male firefighters and one limitedrole fire apparatus.

The demands of emergency service and operational advances at the LAFD in the past half-century, made that 4,190-square-foot station and only slightly larger parcel of land inadequate for providing timely and effective response to the community's needs.

Former Fire Station 62 not only grew cramped and inefficient during its 57 years of service, but also proved deficient in meeting seismic safety, heating, ventilation, air conditioning, electrical, plumbing, Building Code, ADA and separate gender accommodation issues.

In stark contrast, new Fire Station 62 is a capable and appealing long-term asset for all who live in, work and visit Mar Vista, Venice and west Los Angeles.

The new energy-efficient 16,130-square-foot facility was designed with strong community input and built with to support multi-role emergency response needs for many years to come; all while enhancing the effectiveness of a diverse and omnipotent workforce.

#### **ENFORCEMENT VEHICLE:**

Public Works has a new tool in its arsenal to combat blight, illegal dumping, and related violators within the city limits, Board of Public Works President Cynthia M. Ruiz said Jan. 31. "It is a retrofitted white 2007 Dodge Charger Bureau of Street Services Investigation and Enforcement vehicle to allow our investigators to perform their tasks more effectively," Ruiz said.

Funded through a \$300,000 Waste Tire Grant from the

California Environmental Protection Agency's Integrated Waste Management Board, the new vehicle has been designed to augment Investigation and Enforcement Division efforts in conducting surveillance activity, making arrests and transporting violators to community police facilities.

"With black and sliver accessories, the new vehicle has an inside cage, light bar, front push bar to push offending inoperable illegal dumping vehicles from the street, an inside microphone, outside speakers, and spotlights on each side," said Chief Street Services Investigator Gary Harris. "A laptop computer bay to download data gathered from a surveillance camera is included to allow investigators to run license plates and complete related tasks."

Street Services Investigation and Enforcement Division primarily is responsible for public property and protecting citizens from injuries and accidents that could occur from hazardous and dangerous conditions on public property. "The Division enforces a variety of Municipal Code Sections and Board of Public Works regulations enacted to protect public property, ensure public safety and minimize the City's exposure to liabil-




The new Public Works Enforcement Vehicle, to combat blight, illegal dumping, and related violators within the City limits.

ity," Harris said.


"Investigators eagerly welcome this new stateof-the-art unit. We expect it to give us a critical advantage in combating blight and apprehending illegal dumping violators," said Senior Street Services Investigator Rodney Lucas. "It will allow our investigators to perform their tasks more effectively throughout the City, particularly in severely impacted locations of Los Angeles and the San Fernando Valley."

Over the past two years, the Investigations and Enforcement Division has been responsible for 125 illegal dumping arrests, saving more than 500 hours of sworn police officer patrol time. Investigators also have issued 4,320 Notices to Abate Nuisance and conducted 1,810 administrative hearings for illegal dumping during the same time period.

The City offers a \$1,000 reward for information resulting in the identification, apprehension and conviction or final adjudication of persons committing the act of illegal dumping. To qualify, the person reporting the crime must have been involved in the conviction or final adjudication. To report an act of illegal dumping, call 3-1-1, the City's 24-hour, non-emergency hotline.



# Renters Have Much That Needs Insuring



Just because you rent doesn't mean that you don't own anything valuable. Like a homeowner, you should make every effort to ensure that you are protected in the event of a disaster.

Although landlords do carry insurance policies, they don't protect your personal assets in your apartment. You are responsible to make sure that you can replace anything "within" the walls of your apartment or rented home in case of a problem.

What would happen if you returned home tonight, and all you saw was some smoldering ashes and a few firemen reeling up their hoses? Renters also experience much higher rates of burglary and theft than homeowners. Renter's insurance also covers theft, and can help you replace any stolen items that you might have.

There are several types of residential insurance policies. The HO-4 policy is designed for renters, while the HO-6 policy is for condo owners. Both HO-4 and HO-6 cover losses to your personal property from 16 types of perils:

- Fire or lightning
- Windstorm or hail
- Explosion
- Riot or civil commotion
- Damage caused by aircraft
- Damage caused by vehicles
- Smoke
- Vandalism or malicious mischief
- Volcanic eruption
- Falling objects
- Weight of ice, snow or sleet
- Accidental discharge or overflow of water or steam from within a plumbing, heating, air conditioning or automatic fire-protective sprinkler system, or from a household appliance
- Sudden and accidental tearing apart, cracking, burning or bulging of a steam or hot water heating system, an air conditioning or automatic fire-protective system
- Freezing of a plumbing, heating, air conditioning or automatic, fire-protective sprinkler system, or of a household appliance
- Sudden and accidental damage from artificially generated electrical current (does not include loss to a tube, transistor or similar electronic component)

You'll notice that earthquakes aren't on the list. If you have lots of property to insure, you'll need to buy a separate policy to cover earthquakes.

Renter's insurance also provides you liability coverage. If someone falls in your apartment and gets hurt, you might be liable.

Surprisingly, a basic renter's insurance policy usually costs only around \$200 per year. Renters with expensive personal possessions or who need larger liability coverage will pay more. Your own quote will depend on a number of factors, including your previous insurance history and where you live. Despite the low cost and high benefits, a recent poll found that 64 percent of people living in rental properties had no renter's insurance.

You will also have to decide between Actual Cash Value (ACV) or Replacement Cost Coverage for your belongings. ACV coverage will pay only for what your property was worth at the time it was damaged or stolen. Replacement cost coverage, on the other hand, will pay what it actually costs to replace the items you lost, again minus the deductible. Replacement cost coverage will cost you a little more in premium, but it will also pay out more if you ever need to file a claim.

Make sure to inventory all of your personal belongings. Your inventory should list each item, its value, and serial number. Photograph or videotape each room, including closets, open drawers, storage buildings and your garage. Keep receipts for major items in a fireproof place.

If your apartment or condominium becomes uninhabitable due to a fire, burst pipes, or any other reason covered by your policy, your insurance will cover your Additional Living Expenses. Generally, that means the policy will pay for you to live somewhere else. This coverage has a limit of about 30 to 50 percent of the total value of the policy.

# Will Budget Crunch Affect City Employees?

# ■ At press time, Council is deciding how to fix a \$155 million deficit.

COUNCIL — Will the current City budget crisis affect you? Has it already?

At Alive! press time, the City Council is deciding how to solve a big - and growing - problem: a City budget deficit estimated at \$155 million.

The City budget is vulnerable to a number of economic factors, including the real estate crunch, the just-ended Hollywood writer's strike, and the general softness of the economy.

At the end of January, Mayor Antonio Villaraigosa held a press conference to ask the City Council to reduce the City budget by suspending most hiring, asking some workers to take unpaid furloughs, and selling vacant fire stations.

"My priority has got to be public safety," Villaraigosa was quoted as saying at a City Hall news conference. "Keeping the City safe is the answer to how we support revenues."

The Council began its hard work trimming the budget in early February, in some instances looking for ways to increase revenue. But at that session, the Council froze new hires in most departments and delayed the opening of two police stations by several months. And two potential cuts – halting the purchasing of new books by the Library Dept., and cutting funds for graffiti removal - were delayed.

More controversial proposals, including selling surplus property and sharply restricting the program that allows some City employees to use City vehicles and take them home, were also

# Phone Tax Passes; Service Crisis Averted

**■ City voters approve** amendments to telephone tax that could have made City budget even more difficult.

CITY HALL — For weeks, Police Chief William Bratton and Fire Chief Douglas Barry were on TV, warning of the dire consequences Proposition S didn't pass. And, in good news for City Employees, they were plenty convincing.

In a nearly two to one landslide in the election Feb. 5, City voters approved Proposition S, a measure that, while reducing the tax from ten to nine percent, also guaranteed that the tax would be secured in place, and that it would be applied consistently across a wide variety of devices.

The measure was estimated to be worth nearly \$250 million in annual revenue for the City. That revenue, as Chiefs Bratton and Barry voiced in commercials, is critical to keep the LAPD and LAFD strong. Without it, they said, services could

be cut. With the passage of Proposition S, that is longer the case, at least as far as phone taxes are concerned.

Proposition S technically reduced the tax on telephone usage from ten percent to nine percent, but it also broadened the tax to cover all calls regardless of the technology used. Measures are advancing through the courts that could challenge the ways taxes can be applied to telephone technology, but the passage of Proposition S supersedes those court challenges.

# **HARBOR IS 'CLIMATE ACTION LEADER':**

Announced on Jan. 30, the Port of Los Angeles has earned the designation "Climate Action Leader" from the California Climate Action Registry, becoming the first port in the state with this distinction. The Leader status was granted the Port of Los Angeles upon acceptance of its 2006 baseline greenhouse gas (GHG) emission inventory by the California Climate Action Registry, a nonprofit public/private partnership that serves as a voluntary greenhouse gas registry to protect, encourage and promote early actions

to reduce GHG emissions.



"This is just one more step to show the region, state and country how serious we are about greening and growing the Port of Los Angeles," said Geraldine Knatz, Ph.D., Port of Los

Angels Executive Director. "The Port of Los Angeles voluntarily tracked greenhouse gas emissions and created a baseline from which we are able to gauge changes in the gases going forward. We are proud to be the first port in California to be included in the Registry and to hold the 'Climate Action Leader' designation."

The Port has taken a proactive position to recognize and reduce the impacts of greenhouse gases in the Port area. The Port included the impacts of greenhouse gases in its recentlyapproved Environmental Impact Report (EIR) for its Tra Pac Terminal Project - the first Port in the country to include GHG emissions in an EIR document. The Port's 2006 GHG emission inventory may be viewed at www.climateregistry.org/CAR-ROT/public/reports.aspx.

The Port has embarked upon an unprecedented array of environmental initiatives aimed at reducing the effects of Port operations on the environment. Chief among these is the Clean Air Action Plan (CAAP), created in concert with its neighbor, the Port of Long Beach. This comprehensive Plan addresses emissions created by the trucks, oceangoing vessels, trains, terminal equipment and harbor craft that serve the Port and outline measures that will decrease those emissions by nearly 50 percent by 2011.



# **President Ed Harding reports:**



In just a few weeks, April 10, we will be attending one of our General Membership Meetings at the Van Nuys / Sherman Oaks Senior Center, 5056 Van Nuys Blvd. The meeting starts at

1 p.m. You can come for a free lunch at noon, but only if you have made a reservation at least a week in advance by calling one of the officers on the Retirees Helpline.

Director Americo Garza, in charge of entertainment, reports that our luncheon will be better than our last one. He has ordered lemon chicken, legs and thighs, and all the goodies.

On Feb. 28, we are scheduled to meet with President Robin Welbor and Director Lee Kebler of the L.A. Retired Fire and Police Association, Inc., and Dolores Foley of the Retired Water and Power Association. One idea we will be discussing will be the Preliminary Audit Recommendation to Create a New Investments Function. It seems the City Controller wants to commingle the Pension Funds of the L.A. Fire and Police Pension system (LAFPP) and our Pension System (LACERS) and create a new commission and staff to do all of the investing for both funds.

Keith Richman has been circulating petitions for an initiative titled Public Employee Benefits Reform Act (also known as the Richman initiative) to go on the state ballot. As of this writing, I don't know if he has received enough signatures to have it put on the ballot. It would eliminate all current pension systems for all public agencies in the state and replace them with a 401-K or similar system.

Your Medicare Part B premiums could be affected if you sell a home or other asset in which you have built up significant capitol gains. Each year, Social Security reviews your most recent tax data to determine your Medicare premium. The higher you're adjusted gross income, the higher will be your premium.

If a retiree marries after retirement, the new spouse doesn't get any retirement benefits. The Retired Fire and Police Associations is trying to have a charter amendment put on the ballot that could give the new spouse some retirement benefits by reducing the retiree's pension to

finance it. If this gets approved by the voters, then LACERS will attempt to obtain a similar benefit for its members by amending the Administrative Code. They do not require a charter amendment. Stay tuned.

The L.A. Federal Credit Union is offering its members the opportunity to develop a Home Equity Line of Credit, so they can access cash to cover any expense including home improvements, education, etc. Call (877) 695-2328, ext. 7702 or stop at a branch office. LAFCU also offers investment and insurance services with CFS, a broker-dealer.

# **Legislative Update:**



California Supreme Court has accepted the San Diego case for review. Legal advisers expect a decision by this fall.

Some time ago, my committee (Benefits Administration) and the LACERS Board

of Directors unanimously approved authorizing a dental subsidy for our surviving spouses. Currently we have 3,084 surviving spouses, and 1,274 are in a LACERS dental plan.

Councilmen Bernard Parks and Dennis Zine were kind enough to put in a Council motion to support the subsidy.

The CAO report to the Council indicated the cost would be \$1.9 million per year with \$1.3 million from the General Fund and \$600,000 from special funds. (I disagree with both numbers.) The CAO further reported that all benefit enhancements should be considered in the content of all benefits available to retirees. Also, the City has only considered cost neutral benefit enhancements. The CAO said, "We cannot recommend that this benefit

be approved." The matter was "received and filed.


The matter of combining the LACERS and Fire and Police Pensions investment programs is again being considered. A new department and commission (without a retiree member) would be formed. Unless supplemental information is generated, I intend to oppose the audit recommendation. If it's such a good idea, why isn't the Water and Power investment program included?

Recession or not, our retirement fund is still healthy.

# Falling for Zimbabwe

■ Hal's African adventure continues at Victoria Falls. Part three of four.

et's continue the story of our trip to

After lunch at Camp Duma Tau, our baggage was loaded into the Land Rover and off we went to the airstrip to catch our plane. This plane was a Cessna 206, a seven-seater, just large enough for the pilot and the six of us. We were flying to Kasane on the border of Botswana and Zimbabwe, and then we would drive across the border to Victoria Falls. Because of the continuing unrest within Zimbabwe, I had some concerns about traveling within the country and was waiting to see how we would be treated as we crossed the border. A guide from Wilderness

Safaris met our plane, and we started the short drive to the border crossing. I asked our guide how long the trip would take, and he said about an hour, unless we were held up at the border. When we reached the border, we were the only people crossing. We all got out and entered the office and presented our passports

and a \$30 visa fee, which

had to be paid in hard cur-

rency (dollars). They stamped our passport, and we were on our way in about 10 minutes; so much for my concerns. During the remainder of the drive to Vic Falls, we had to stop twice to let elephants cross the road.

Zimbabwe is a land-locked country in central-southern Africa that straddles the Tropic of Capricorn. It is about the size of California and has a population of about 13 million. Britain annexed Southern Rhodesia from the South Africa Company in 1923. A 1961 constitution was formulated to keep whites in power. In 1965, the government of Ian Smith unilaterally declared its independence, but

Britain did not recognize the act and demanded voting rights for the black African majority in the

> country, now Rhodesia. United Nations sanctions and a guerrilla uprising finally led to free elections in 1979 and independence, as Zimbabwe, in 1980. Robert Mugabe, the nation's first prime minister, has been the country's only ruler and has dominated the country's political system since inde-



pendence. English is the official language.

Driving up to the Victoria Falls Hotel was like taking a step back into history. The hotel was built in 1904 when the Cape to Cairo railway reached the falls. It has played host to visiting members of the royal families, international and local statesmen and celebrities and maintains an atmosphere steeped in history, combining the charm of the old with the comfort and convenience of today. The rooms have all been refurbished to provide a perfect balance of modern amenities without losing the grand Edwardian architecture. It is set in acres of lush lawns and exotic flora. It is only a short walk from the center of town and only ten minutes from the actual falls. From our room we could see the large clouds formed by the spray over the falls, while the rest of the sky was clear and blue.

After checking into our room, we left for our visit to the falls. Victoria Falls is one of the seven natural wonders of the world and is the largest curtain of falling water on the earth. It was discovered by David Livingstone in November 1855 and is known by the local name of "Mosi Oa Tunya," or the "Smoke That Thunders." The falls creates its own weather, and we each received plastic ponchos to protect us from the rain. The trail we followed was about a mile long, and we were able to see the falls from a number of different viewing points. One of the most dramatic is Cataract View, the westernmost point, which requires climbing down a steep stair-

way in (and out of) the gorge. While the sun was shining brightly all around us, the sky above the falls was covered with clouds and we were rained on the whole time. The area around the falls is a spray-generated rain forest unlike the normal environment. Before returning to the hotel, we stopped to view the Zambezi Bridge and watch the tourists bungee-jump.

That evening we had dinner at the buffet in the hotel. It was one of the best buffets we have had, and we also enjoyed the entertainment, which was local dancing.

The next day was a free day to allow us a little rest and a chance to see the town and do some shopping. The town of Victoria Falls was built on tourism and reminded us of Tijuana. The streets are lined with small stores selling locally made souvenirs and crafts. Prices were fixed, but you could negotiate the rate of exchange. This brings me to our story on the rate of exchange.

On the drive to Vic Falls, I had asked our guide what the exchange rate was between the Zimbabwean dollars (ZWD) and the U.S. dollar. He told us between 90 and 100 ZWD to \$1. (The rate of exchange has changed dramatically since our trip, and is now \$1USD to \$30,000 ZWD). When we arrived at the hotel, I had noticed that the hotel was giving 70 ZWD to \$1, but I figured that you get the best rate of exchange at a bank or the official bureaus de change. We weren't too concerned about exchanging money because we could use our credit cards and you always get a better rate of exchange using the card (not including credit card service charges and fees). On the way to town, we stopped at a bank to see what the official rate was and were surprised to see it posted as 52 ZWD to \$1. This got us to thinking, and as we walked to town I saw a bureaus de change and they were offering 80ZWD. By this time we were a little confused, and I when into a shop and asked what rate they would give, I was told 100 ZWD. To



make a long story short, we ended up exchanging U.S. dollars for between 110 and 120 ZWD and used only ZWD to pay while we were in Zimbabwe. When we returned to the hotel we immediately paid our bill in ZWD instead of charging it to our credit cards. It was the first time we had come across reverse arbitrage. Because the official rate was 52 ZWD and we were getting over 100 ZDW, we did get some very nice bargains -- this area of Zimbabwe is known for its stone carving, and we purchased a nice piece to bring home. To close out the money story, at our next camp in Zimbabwe they had a store priced in U.S. dollars, so we exchanged our ZWD back at the official rate. So we made out coming and

We returned to the hotel in the afternoon and had high tea at Stanley's Terrace overlooking the falls. At our good rate of exchange it was about \$3.50 per person, which included tea, finger sandwiches and dessert. We also had a light dinner on the Terrace later that evening. We really enjoyed our stay at Victoria Falls; we got to catch up on the news (CNN and BBC) and read a newspaper and we called home to see if everyone was all right.

The next morning, we were picked up and driven to the Victoria Falls Airport and boarded another Cessna 206 for the flight to our next safari camp.

Next month I'll finish up the trip.



# Water for His Homeland

PUBLIC WORKS — The Board of Public Works honored Bureau of Street Services Maintenance Laborer Tom S. Eng Jan. 28 for his humanitarian work to bring wells to five villages without water and power in his native Cambodia.

A survivor of the Khmer Rouge of Cambodia, Eng fled the war and regime that led to the execution, starvation and forced labor of an estimated 1.6 million people out of a population of 7.5 million between 1975 and 1979.

Impoverished, without food, clothing or medicine, Eng left his village in Kandal Province, approximately 28 miles north of Phnom Penh, the capitol of Cambodia. He walked for one month, approximately 300 miles, to reach the Cambodian and Thailand border to escape the Khmer Rouge. There he spent the next six months in a Thailand refugee camp and the following two years learning English. On Aug. 16, 1983, the United Nations brought Eng to the United States as a Khmer survivor where he arrived in Los Angeles to begin a new life.

Eng began his career with the City in October 1999 with the Bureau of Street Services (BSS). He was employed as a vocational worker assigned to the Resurfacing Division and then was promoted and reassigned as a maintenance assistant with the Lot Cleaning Division. He was promoted in August 2005 to maintenance laborer and currently drives an over-cab-loader in the removal of illegally dumped debris. He recently obtained a Building and Safety Equipment License, allowing him to be trained in heavy equipment.

In October 2006, he traveled back to Cambodia to help his surviving family members and neighboring villages with the support and donations from his colleagues at BSS. Eng has one brother and four sisters who live in Cambodia. Eng went to Cambodia to construct five wells in five villages that have no water or

electricity. The World Health Organization estimated that access to potable water had improved by 2003, but the projection included nearly twothirds of the rural population and one quarter of city inhabitants relied on unsafe water sources.

Eng returned to Cambodia in November to contract and construct six new wells in five more villages with donations from BSS employees in the Lot Cleaning and Resurfacing Division as well as Jorge Sanchez of Local SEIU. Eng received donations totaling \$1,300 and matched their donations with money he had saved working overtime. The six wells brought water to an estimated 320 families that had previous walked miles to the local source with four-gallon containers. The estimated cost for the construction of each well was \$300 to \$600.

Eng said that, after receiving his certificate of recognition, he intended to return to Cambodia this November to deliver medicines, dried goods, cooking oil and clothes. The United Nations Population Fund estimated that the average per capita income is at no more than \$290 annually, and that close to 40 percent of the entire population lives below the poverty line. The fund also projected that rural households comprise up to 90 percent of the country's poor.

Ron Olive, Assistant Director of the Bureau of Street Services, and his colleagues from the Lot Cleaning and Resurfacing Divisions, with representatives from SEIU, all expressed their support and admiration for Eng's effort to give back and make a difference for his native country.

"Existence without water places people under extraordinary stress so the nexus between clean water and a better quality of life is clear for locations that must rely upon retaining ponds or faraway rivers—everything changes for the better with the addition of a well," said Cynthia M. Ruiz, president of the Board of Public Works. "We are extremely proud of Mr. Eng and the support he received that resulted in a more sustainable environment for these villagers in Cambodia."


All the members of the Board of Public Works commended Eng's commitment to help bring well water to villagers in his native country and praised his efforts and the efforts of his supporters as emblematic of our humanity and collective duty to try and help the destitute and needy.



A depiction of the Alive! Around the World map at Club Headquarters



# Funny Games (1997)




Casey Affleck's performance holds together an otherwise preachy whodunit about police corruption, drugs and bad parenting in this portrait of a high-crime part of





# **DIRECTIONS:**



Step 1: Wash and prepare all ingredients. Dice the celery, potatoes, the red onion, asparagus, parsley and tomatoes.



Step 3: In a pan on medium heat, place extra virgin olive oil and transfer diced ingredients to the hot pan. Stir occasionally and allow the ingredients to brown. This may take about five to 10 minutes.



Step 5: Add the mustard to the albacore tuna steaks. I like adding it to just one side, but feel free to add mustard to cover both



Step 7: Place the albacore tuna steaks on iron skillet (or a grill or pan). Cook on medium heat and remove when both sides are golden brown. Once removed, place some parsley and the diced tomatoes to cook for about one minute and remove as well.





Step 2: Place diced ingredients on a platter and add salt and pepper here.



Step 4: Prepare the parsley and diced tomatoes by leaving them on a plate for a quick cook on the pan just before plating



Step 6: Add the cumin, salt and pepper on both sides.



Step 8: Plate the albacore tuna steak on top of a bed of the sautéed vegetables.

# Tasty to the (Alba) Core

or this month's recipe, I was supposed to bake albacore tuna steaks in a For this months recipe, I was supposed to the banana leaf wrapping. But it didn't work out, since I had a tough time locating banana leaves. (Wouldn't you know it, though, a new stock of leaves arrived at the market a day after the photo shoot for this article.) So, while that recipe is in the works for a future column, I thought I would offer an excellent recipe with mustard and albacore tuna steaks.

It might be hard to believe, but mustard goes very well with fish. I've experimented with many types of mustards, and I can tell you that you cannot go wrong with any of them. One of my favorites is Dijon mustard for its slightly spicy taste. Some of the best fish recipes use a foundation of just mustard, salt and pepper. Actually, give that a try sometime, too. It's simple but highly deli-

In this recipe, I used a seasoned iron skillet, but you may use a nonstick pan as well or a grill. Please be careful using any other type because the fish may stick to the pan and tear.


# Pan-Seared Albacore Tuna Steaks a la Mustard

Serves 2, Prep Time: 30-40 Minutes

# INGREDIENTS:

- 1 pound of Albacore tuna steaks
- 1 celery stalk
- 2 small white creamer potatoes
- 1 red onion
- 4 asparagus stalks
- 1/4 cup Italian parsley
- 2 small Roma tomatoes
- 1 lemon
- 1/4 cup extra virgin oil
- 1/4 cup mustard (enough to generously cover one side of the albacore tuna steak)
- Salt and freshly cracked pepper
- 2 tablespoons of ground cumin





Step 9: Add the tomatoes and parsley at the end. If you like parsley like I do, feel free to add more. Enjoy!


