

## There's One Final Month for Your Comments on LAX Expansion Plan

■ Proposed plan to guide LAX well into the future is open to comments, but only until Nov. 7. Make your voice heard.

City employees—and everyone with an opinion to share on the proposed master plan to expand LAX—now have until Nov. 7 to make their comments known, so don't wait if you have something to say.

The Federal Aviation Administration (FAA) approved a 75-day extension of the public

review and comment period for the Supplement to the Draft Environmental

Impact Statement/Environmental Impact Report for the LAX Master Plan for a total of 120 days and the scheduling of three additional public hearings. The comment period will now end on November 7, 2003.





# Newsbriefs

## HYDROGEN CARS

General Service's Fleet Services division has taken delivery of 5 hydrogen-powered cars from Honda. Mayor Jim Hahn has announced an agreement between the City of Los Angeles



and American Honda Motor Co., Inc., to make Los Angeles the first U.S. retail customer for a fuel cell car. Mayor Hahn took delivery of the nation's first fuel cell car certified for commercial use, the Honda FCX.

The vehicle is one of five put into service by the City for every day use and represents a big step forward in vehicle technologies utilized by the City of Los Angeles. The hydrogen fuel cell represents one of the most promising "clean" alternatives for fueling vehicles, as water vapor is the only exhaust. The 2003 Honda FCX is powered by a hydrogen fuel cell that produces electricity onboard the vehicle. A fuel cell functions by combining hydrogen (stored in a tank) with oxygen in the air to make electricity (and water as a by product). The electricity is used to power the electric motor, which in turn propels the vehicle. Both the California Air Resources Board and the United States Environmental Protection Agency have certified the Honda FCX as a Zero Emission Vehicle and for every day commercial use.

## LABONGE IN TRAFFIC

Councilmember Tom LaBonge has put forth several key initiatives to ease traffic congestion in Los Angeles and has made traffic mobility a key priority of his administration. They are:

### 101 Corridor Improvements

- Created a 101 Corridor Task Force that favors re-engineering and/or improving the freeway to increase mobility at on-ramps and off-ramps (acceleration and deceleration lanes) and at interchanges without expanding the roadway or taking property.

- Working with Caltrans and LADOT to make sure process includes input from affected communities, homeowner groups and neighborhoods and certified area Neighborhood Councils.

### MTA

- Working to pass SB314, a half-cent local sales tax increase to fund a number of transportation projects in Los Angeles, including extending the Red Line west along Wilshire Boulevard to Fairfax Avenue.
- Supports developing San Fernando Valley North-South Rapidways, building a light rail line to

the West Valley and creating a viable transportation network throughout the Valley that provides connectivity within the Valley to other modes of transportation such as MetroLink.

- Expand hours of Red Line and DASH.

### Traffic Mobility Initiatives Submitted in Council

- Ban construction and repair work on primary surface streets during peak traffic hours. *Status- Approved by Public Works Committee, ordinance being drafted by Public Works Committee.*
- Place Department of Transportation officers at top 25 intersections in City to help control traffic flow. Reassign hours of DOT traffic officers. *Status- Implemented successfully at Hollywood and Highland and several intersections along Ventura Boulevard in Valley. Report pending on having DOT traffic control officers work a 6-2 schedule, meaning 6 hours writing tickets and 2 directing traffic.*
- Create high-level LAPD officer to oversee traffic issues. *Status- Working with department to include Commander-level position in Special Operations Bureau to supervise traffic divisions in 2004-05 budget request.*
- Create 24-hour local traffic radio station. *Status- Information Technology Agency developing proposal to establish network of mini radio transmitters to share traffic information concerning major city arteries.*

### Imagine Walking Along the Waterfront in Los Angeles

There is nothing like strolling along the waterfront, smelling the ocean air and enjoying the view. Whether it is San Diego, Baltimore, San Francisco or Seattle, we have all visited other cities with exquisite seaport villages, wharves or waterfront development—something that has been lacking in the City of Los Angeles.

That is about to change.

When the Mayor and I took office in 2001, we decided to return a large portion of the waterfront at the Port to the people of this City. All the way from the Vincent Thomas Bridge to the Harbor breakwater was designated for recreational use. And right now, we are in the process of creating a world-class waterfront promenade for all of Los Angeles to enjoy. I envision visitors from all of the city, and beyond, walking along our waterfront, visiting shops, dining at restaurants and enjoying the incredible entertainment provided by the Port of Los Angeles. Our promenade will draw visitors not only from around the world and increased tourism will help us to attract and retain new businesses and generate new jobs benefiting every Angeleno.

To make our waterfront development a reality, it will be up to the residents of L.A. to approve a ballot measure in March. This ballot measure will amend our City Charter by just one line—but what a difference a line can make. Voting yes on the “Tidelands Trust” charter amendment will give Los Angeles the ability to use port-

related funds for uses including education, recreation, culture and tourism—an ability that every other port in California already has and what we need to build the waterfront we deserve.

Many people may wonder if is possible to combine entertainment and recreation with a working harbor. But, our harbor is our entertainment. With cruise ships, cargo ships, barges, tugs and our new fireboat—which is the most powerful in the world—visitors will be constantly amazed.

Waterfront development is crucial to the economic prosperity of coastal California cities. We plan to break ground on our promenade as early as February 2004, and I invite every Los Angeles resident to stroll along the waterfront when we open our grand promenade. Keep your eyes open for that March ballot measure. We will be looking to you for support. 



Could you soon be walking along a waterfront in Los Angeles? Councilmember Janice Hahn hopes so.







I have 10 outstanding section managers reporting to me, helping me solve the daily problems that are part of any active airport operation. For example, with the help of these managers and their staff, OIA was able to effectively respond to the crisis of September 11, a very difficult time for airports. The 9/11 tragedy resulted in a major reduction of airport operating revenues and we were faced with having to significantly cut back our 2002-03 budget. Thanks to the hard work by the OIA staff, we were

able cut the budget with no layoffs and no serious loss of resources. This could not have been accomplished without the good people working here at OIA.

And that leads me to the second reason I like working at OIA, and that's because the airport is large enough to handle 120 commercial flights and yet small enough that I can have a hand in all of the operations, from ground transportation, to cargo development, to police and fire functions, maintenance, airfield operations, property management, and all the rest. It's something different every day, and that makes the job enjoyable.

A unique aspect of my job is that OIA, while owned by the City of Los Angeles, is not only located in a different city, Ontario, but also located in a different county, San Bernardino. So while I report to my bosses in the City of Los Angeles, I also have much interaction with my other "bosses," the community and civic leaders of the Inland Empire. These people are as proud of OIA as are the LA City Employees who make it successful. 🏆







# Ontario International Airport: A Hub in a Fast-Growing Region

Ontario International Airport (ONT) is a medium-hub, full-service airport with commercial jet service to major U.S. cities and through service to many international destinations. ONT is located in the Inland Empire, approximately 35 miles east of downtown Los Angeles in the center of Southern California. The airport is the centerpiece of one of the fastest-growing transportation regions in the United States.

ONT's service area includes a population of six million people living in San Bernardino and Riverside Counties and portions of north Orange County and east Los Angeles County. Passenger traffic at ONT has been increasing steadily for the past 10 years. In 2002, 6.5 million passengers used the airport, and 547,461 tons of air freight were shipped.

ONT's 214 daily flights provide service to every major city in the U.S. ONT's airlines include AeroMexico, Alaska, America West, American, Continental, Delta, Frontier, Hawaiian, jetBlue, Linesas Aereas Azteca, Northwest, Southwest, United and United Express.

The "new" Ontario International Airport opened September 27, 1998. The \$270 million project includes two new terminals at 265,000 square feet each for a total of 530,000 square feet; a new ground transportation center; an additional parking lot and new roadway system; airfield improvements; landscaping; and a site storm-drain system. The new terminals are eight times larger than the former terminal and can accommodate up to 10 million passengers a year. When passenger traffic at ONT reaches 10 million in two consecutive years, a third terminal will be constructed.

ONT is also the center of a rapidly developing freight movement system that includes the airport, two railroads, four major freeways, and an expanding network of freight forwarders. ONT is served by 11 major U.S. air freight carriers including Airborne Express, Ameriflight, DHL, Empire Airways, Evergreen, Express Net, Federal Express, Kalitta Air, West Air, Union Flights, and United Parcel Service.

ONT is a member of the Los Angeles World Airports system and is ideally situated as an airfreight center for Pacific Rim and European cargo. The airport is less than 50 miles from Los Angeles and Long Beach Harbors. 🏢

### NEW INTERNATIONAL CARGO FACILITY OK'D FOR ONTARIO

The Los Angeles Board of Airport Commissioners has approved the selection of Aero Ontario LLC (Aeroterm) and author-



ized the executive director to negotiate a long-term land lease and agreement with Aeroterm to develop an international air cargo center at Ontario International Airport (ONT).

"Cargo to the southern California region is expected to triple over the next 25 years," according to Richard Janisse, Deputy Executive Director of Properties and Concessions for LAWA. "As the primary capacity at LAX for air cargo is limited, it is only a matter of time before freighter operators have to move inland. Ontario is the perfect choice for us due to its location and potential for development."

ONT handles more than 500,000 tons of air freight each year (547,461 tons in 2002), and is showing a 6.85 percent increase in 2003 over the previous year. The proposed cargo

center site would be located on underutilized land in the northwest quadrant of ONT and includes the former Lockheed Martin site, vacated in 1998, as well as a LAWA controlled aircraft parking area.

"The entire property measures 105 acres," Janisse said. "Most improvements on the site are well beyond their economic and functional lives and would be demolished as part of an overall development plan."

The impetus for the air cargo project continues to be increasing concern over the readiness of Southern California to accommodate anticipated growth of air cargo operations in the region. The Southern California Association of Governments (SCAG) Regional Transportation Plan projects 9.5 million tons of air cargo for the year 2025, with more than 2 million tons at ONT.

The City of Ontario supports the proposed air cargo development plan, and the ONT Master Plan has determined that cargo operations at the site would be a compatible land use.


### ONTARIO, LAX SECURITY COSTS PARTIALLY REIMBURSED BY FED

Los Angeles Mayor Jim Hahn and the U.S. Department of Homeland Security (DHS) have signed a Letter of Intent to reimburse Los Angeles World Airports (LAWA) \$256,467,000 to defray the cost of installing permanent explosive detection systems integrated in-line with the checked baggage conveyor systems at Los Angeles International Airport (LAX) and Ontario International Airport (ONT).

The federal reimbursement represents 75





percent of the total costs at both airports estimated at \$313,408,000 and \$28,548,000 for LAX and ONT, respectively. The LAX portion of the reimbursement (\$235,056,000) is the largest federal grant received for a single project at LAX in the airport's 75-year history.



LAX and ONT serve more than a combined 63 million passengers annually, generating more than \$65 billion in economic activity, and providing nearly 470,000 jobs.

The Letter of Intent is the result of an agreement negotiated between LAWA and the TSA outlining the federal agency's intent to reimburse LAWA, from TSA's future appropriations over the next four years, 75 percent of LAWA's cost of capital improvements to install the in-line explosive detection systems, while LAWA agrees to cover the remaining 25 percent. LAWA agrees to initially fund the projects at both airports. The TSA will reimburse LAWA \$55 million for federal Fiscal Year 2004, and \$67,155,666.67 for each of the three subsequent years. These figures do not include the


cost of the explosive detection equipment, which TSA will purchase, install and test, according to a schedule agreed upon with LAWA.

Permitted capital improvement costs include: preliminary site preparations, structural reinforcement to support new equipment, electrical work, heating and air conditioning and other environmental improvements, as well as conveyor belts and tables, and physical enhancements necessary to operate an in-line system.

## NEW ONTARIO TAXIWAY ON TIME, UNDER BUDGET

Ontario International Airport's (ONT) \$20.2 million Taxiway N Westerly Extension Project was completed two weeks ahead of schedule and \$1 million under budget. The new taxiway was scheduled to open Sept. 22.

"The extended taxiway will facilitate movement of aircraft on the ground at ONT and allow for more efficient use of the airport's two parallel runways," said Airport Manager Jens



Rivera. "The new taxiway is also the primary access to the proposed international cargo site located at the northwest corner of the airport."

The project included construction of a new 75-foot-wide concrete taxiway with asphalt shoulder, taxiway edge and centerline lighting, lighting vault modifications, and the relocation of a Federal Aviation Administration's glide slope facility and a security airfield vehicle checkpoint. In addition, the new concrete taxiways and runway intersections were designed and constructed to be compatible with the future Runway 26R Reconstruction project that is under design and scheduled to begin construction next year.


Los Angeles World Airport's (LAWA) Project Management Division managed the design, construction and inspection of the Taxiway N project. CH2MHill, Inc. was LAWA's design consultant for the new taxiway and Griffith Company from Riverside performed the construction work. Paragon Project Resources, Inc. provided on-site construction management services during the construction phase. Construction began in November 2002.

## UNITED PICKS ONTARIO INTL. FOR LOW-COST ALTERNATIVE

Ontario International Airport (ONT) will serve as one of the first destinations for United Airlines' new Low Cost Operation, the airline announced in September. Viewed as an essential element of its air service program, United plans to market its new Low Cost Operation to serve predominantly leisure markets, featur-

ing a simplified fare structure with low-cost business and leisure fare options. The new air service is scheduled to launch from Denver International Airport in February.

United's Low Cost Operation plans to operate 156-seat Airbus 320 aircraft at ONT's Terminal 2. Flight schedules are expected to



be announced in the near future with ticket sales to begin next month through all existing sales channels. All seats will be pre-assigned, including Economy Plus seating, with food and beverage service available on board. The airline also plans to unveil its new marketing branding program for the Low Cost Operation in mid-November.

According to United officials, its Low Cost Operation will complement the airlines' mainline and United Express service from Denver, the company's second-largest hub. United plans to begin its Low Cost Operation with four aircraft in Denver, and expand to 40 by the end of 2004. ✈







## Baby Rock Wallaby Makes L.A. Zoo Debut

■ One of the L.A. Zoo's newest animals is a baby yellow-footed rock wallaby, born to mom Marrinya and dad Goolang.

The birth is significant because this joey was born to parents whose genetic bloodlines are new to North America. They came to the L.A. Zoo a year ago.

Yellow-footed rock wallabies are from the same family as the kangaroo. The difference is that an adult kangaroo can weigh more than 44 pounds while wallabies are smaller, and wallabies have hind feet shorter than 10 inches.



They are found in rocky ranges and stony hills of eastern South Australia, northwestern New South Wales and southwestern Queensland.

Wallabies are nocturnal, spending their days in rock crevices and caves. They feed in the late afternoon and evening.

Wallabies are very agile and can leap very far.

The Zoo has seven adult wallabies and three youngsters. After birth, the young climbs unaided into the mother's pouch, where they stay until they have hair and are developed.

They can be found in the Australian section of the Zoo during normal Zoo hours: 10 a.m. to 5 p.m. daily. Admission is \$9 for adults and \$4 for children ages 2 to 12. 🐾

#### Halloween: Beware of Pet Fright

So you're having a Halloween Party. You're the Grim Reaper. Everything's going great except that you forgot about big lovable Fluffy-the-Dog. You hear a loud shriek from Dracula as Fluffy (who never bites) has his teeth in Dracula's ankle.

Here's something even scarier: There's a knock on the door, you open it and are confronted by pint-sized ghosts, princesses and superheroes. Suddenly, strong and quick Fido bolts out the door and goes for Cinderella's throat. It is a horrifying thought.

Halloween can be a frightening time for many animals. The noise, costumes and activity can be a threatening and bewildering experience —with unexpected results. Constant intrusions by trick-or-treaters, for instance, can make a normally friendly dog frightened or aggressive and cause a complacent house cat to dart out an open door.



#### Take these safety tips to ensure Halloween remains a safe and enjoyable time for everyone:

- Do not take pets trick-or-treating.
- Keep all pets indoors, including those that normally live outside, in a secure, quiet room away from Halloween activity.
- Keep children away from animals. Otherwise-friendly animals may be frightened and behave unexpectedly.
- Keep pets away from jack-o-lanterns and candles.
- Keep traceable identification on pets at all times. Scared animals tend to run and may run away from home.
- Do not give trick-or-treat candy to pets. Candy, including chocolate, can make your animal very sick.
- If you must (I mean really!) dress your pet in a Halloween costume:
- Do not use rubber bands or anything constricting, annoying or unsafe.
- Be careful with ties, snaps or zippers that can restrict breathing or movement.
- Do not place hats, hoods or other material over an animal's face. This can agitate an animal.
- Stay away from bats. You can get rabies from them. If you suspect that you or your pet has been exposed in any way to a bat, immediately seek medical attention and request that you and/or your pet be tested for rabies. 🐾

## LAFD Remembers NYC Brethren With Two Events in Los Angeles

The Los Angeles Fire Department honored the memory of their Fire Department of New York brethren at two events on the two-year anniversary of 9/11. The two events, the first of which was held in Hollywood, and the second of which in Elysian Park, took place Sept. 11, 2003.

### Elysian Park

The long-anticipated unveiling of the Los Angeles Memorial to September 11 took place at the Fire Department's Frank Hotchkin Memorial Training Center in Elysian Park at 2 p.m.

A volunteer team of countless people delivered, prepared and erected a monument to the courage, commitment and sacrifice of those who died in the terrorist attacks at the World Trade Center in New York City. The monument consisted of a 23-ton steel column from the base of the World Trade Center and a plaque attached to its base.


The nearly 20-foot tall column was originally part of the lobby structure of the World Trade Center. The largest remnant of the attacks outside of New York City, it now rests safely on reinforced concrete piles that sunk nearly 30 feet below ground at the LAFD's Training Center.

Mayor James Hahn and local Councilmember Ed Reyes were joined by Los Angeles Fire Chief William Bamattre and other dignitaries at the event.


### Hollywood

The day began at the LAFD Museum in Hollywood, where members of the LAFD Historical Society honored the 343 New York Firefighters killed in the attack on The World Trade Center. The program commenced at 7 a.m. with a formal raising of the American flag, the ringing of bells and a brief ceremony. 🏛️



## LAX Dedicates 9/11 Art Piece Emphasizing Return to Peace

To memorialize September 11, 2001, Los Angeles World Airports (LAWA) and Cultural Affairs Department officials unveiled and dedicated a permanent art piece at LAX on Sept. 10. The artwork is in LAX's historical Theme Building, 201 World Way.

"Our airport was tragically linked to the terrorists attacks on our nation, as three of the four hijacked flights were bound for LAX,"

said Kim Day, LAWA Interim Executive Director. "It is fitting and meaningful to memorialize the day and its tremendous impacts with this artwork here at LAX."

Following a nationwide call for entries, the art and design team of BJ Krivanek and Joel Breaux was selected. The firm created a piece called "Recovering Equilibrium," which, shaped like a compass, features words and phrases that reflect national perceptions, rights and ideals. At night, the words are illuminated and will be projected onto the surrounding areas.

"The text in this art piece came from thoughts and ideas from community members in our surrounding airport areas and I thank those who participated and provided their valued input," Day added.


Board of Airport Commissioners; and Leslie Thomas, Assistant General Manager of the Los Angeles Cultural Affairs Dept.





"Our Club members and their families and friends deserve nothing less." 📖





# Two L.A. Departments Save The Day ... and a Kitten


■ **Two L.A. City Departments — Animal Services and Public Works — came together Sept. 9 to rescue a kitten. The Club congratulations and gives a big Shout Out to all who were involved in the rescue operation!**

A furry black and white kitten was trapped in a storm drain on the corner of Killian Street and Cedros in North Hollywood. Officials are not sure how the kitten got there, as it was too small to likely have gotten there on its own.

Public Works was on scene when the East Valley Shelter was alerted of the situation at around 10:20 in the morning. Animal Control Officer Armando Navarette rushed to the location where he was met by Santiago Vazquez of Public Works. They began to plan out the rescue: The Animal Control Officer would have to use emergency respirator equipment to avoid breathing in toxic fumes. He

had never used this equipment before. Vazquez patiently showed Navarette how to use the equipment. He also made sure the Animal Control Officer understood rescue procedures in a storm drain.

After donning the equipment, Officer Navarette slowly descended into the manhole and made his way into the storm drain. The Public Works crew kept watch right outside the manhole, monitoring him as best they could. Finally, Officer Navarette emerged from the manhole. The Animal Control Officer had captured the kitten, which he carefully handed over to the Public Works crew as they helped him out of the storm drain.





## Newsbrief

### CLEAN WATER

In a move that signals a significant change in environmental protection policy for the City of Los Angeles,



Councilmembers Eric Garcetti and Jack Weiss announced that the City of Los Angeles has dismissed its lawsuit against the Regional Water Quality Control Board over its National Pollutant Discharge Elimination System (NPDES) Municipal Stormwater Permit, and will begin to abide by strict standards for controlling runoff into Santa Monica and San Pedro Bays.

"For too long, the City has fought against environmental regulations in the courtroom instead of fighting for the improvement of water quality on our beaches," said Weiss, who is also Chair of the Santa Monica Bay Restoration Commission. "The decision to dismiss this lawsuit shows that the current Council has made a critical policy shift to commit to protect our waterways and clean up the bay."

"It's time to stop suing and start taking care of our environment," said Garcetti, Vice-Chair of the Council's Committee on Environmental Quality. "Just like individuals, cities have to clean up for themselves. I'm proud that my colleagues have joined Councilmember Weiss and me in taking responsibility for our impact on our coastal waters."

The stormwater system, composed of gutters, drains, catchbasins and pipes, collects rainwater runoff and channels it through a complicated drainage system that ultimately deposits everything it gathers in the ocean. Trash, animal waste, chemicals, and other pollutants are transported untreated through the stormwater system and harm the beach environment. 🌊

# LAX Modernization: What Do You Think? ... So Tell 'Em

addresses of the people and locations to send your comments.

This plan—or whatever plan is finally approved—will have a lot to say about the way thousands of City employees spend their working days for many years to come, so don't be shy about speaking up.

The FAA decision came in response to a request from the Board of Airport Commissioners, which voted unanimously Aug. 11 to request the extension after receiving a letter from Los Angeles Mayor Jim Hahn expressing support of a City Council resolution calling for a total public comment period of 120 days.

### The Proposed Modernization Plan

July 9, Mayor Jim Hahn released the environmental analysis and further details of his plan to modernize LAX as an integral part of a Southern California regional air transportation system.

"The goal of creating this Enhanced Safety and Security Master Plan is to modernize LAX to protect one of Los Angeles' key economic engines," he said. "At the same time, the plan addresses community interests and concerns by designing the facility to serve only LAX's fair share of the total regional air service market."

The LAX Master Plan was placed on a federal streamlining list earlier this year to help facilitate the environmental review process at the federal level.

Mayor Hahn, who serves as the Chair of the U.S. Conference of Mayors Airport Safety and Security Task Force, announced his intention to prepare an alternative to the LAX Master Plan on October 8, 2001. Since then, planners,

engineers and environmental consultants have been working with airport officials to further develop the plan and analyze its environmental impact.

The plan designs the future airport to accommodate approximately 78.9 million annual passengers and 3.1 million annual tons of cargo. These traffic volumes are consistent with the goals established in the Southern California Association of Governments 2001 Regional Transportation Plan to promote growth of underutilized airports in outlying areas and to achieve a more decentralized distribution of future air traffic around the region.

Mayor Hahn said the approximately \$9 billion plan would be designed and constructed in phases over an 11-year period beginning in late 2004. The program would be financed through a combination of airport funding mechanisms, including revenue bonds, grants, concession revenues, Passenger Facility Charges, leases and landing fees. Mayor Hahn pledged that no taxpayer dollars would be expended from the City's General Fund.

The construction of airport improvements suggested in the plan would create nearly 49,000 direct construction-related jobs, pumping millions of dollars into the local economy. Mayor Hahn said it would be the largest public works project in America to require Project Labor Agreements (PLA).

The plan addresses four crucial areas:

- (1) airfield, including runway and taxiway safety improvements;
- (2) ground access (roadways, transit), automobile parking and rental cars;
- (3) terminal facilities; and
- (4) security concerns.

### Airfield Improvements

The North and South dual runway complexes would be modified to improve safety through the addition of center parallel taxiways between the runways. The FAA's latest airport design criteria would be applied to all new facilities developed as part of the plan. The North and South airfield usage would be balanced by lengthening the North runways. These airfield modifications would improve aircraft maneuvering, reduce taxi delay, and increase airfield safety.

### Redeveloped Central Terminal Area (CTA)

Today, LAX serves its passengers through a combination of less than 4 million square feet of terminal landside and airside buildings. This well-used space is inadequate by today's standards and prevents the flexibility to respond to changing security needs.

The LAX Master Plan proposes to bring LAX's terminal facilities into the 21st century by creating a new central landside terminal in the space now occupied by the CTA parking structures. Passenger and baggage screening conducted by the Transportation Security Administration (TSA) would take place in this facility and in close proximity to the aircraft gate areas. This new passenger terminal would be connected to a new North Linear Concourse replacing Terminals 1, 2, 3 and the north side of the Tom Bradley International Terminal (TBIT). The Bradley Terminal would be redesigned to add a new passenger concourse and aircraft gate area on its existing west face. A new Satellite Concourse would be constructed west of TBIT and would be connected to the main terminal by a secure underground people mover. Existing Terminals 4, 5, 6, 7 and 8 would be refur-

bished, as necessary, and connected to the new main terminal building.


The new terminal and passenger concourses would occupy more than 6.5 million square feet of space and bring LAX's passenger facilities up to today's international and domestic standards for all functional spaces.

### Normalized Operations Under Heightened Security

The focus of Mayor Hahn's plan for LAX is to normalize passenger operations under any security circumstance. Meeting security requirements at LAX today are expensive and disruptive to the daily movement of people and goods through the airport and on local area streets. The Master Plan improvements would create the space and separation needed to balance the needs of airport users with the facilities, systems and tactics necessary to protect lives and airport infrastructure from those who aim to disrupt and destroy commerce in the United States. The plan provides the space and flexibility necessary to meet the evolving federal security requirements.

The plan would employ the latest evolving technologies to identify and intercept all threats through checked and carry-on baggage. It would also eliminate the possibility of major disruptions to airport operations by removing all non-essential vehicles from the Central Terminal Area/central processing area of the airport.

A security analysis of the Enhanced Safety and Security Alternative performed by Science Applications International Corporation (SAIC) is included in the Draft Master Plan Addendum. It concludes that Alternative D is "overwhelmingly a better plan for LAX than the No Action/No Project Alternative. The ability of Alternative D to be flexible to meet future security needs is an optimal, forward thinking design." SAIC is the nation's largest

employee-owned research and engineering company, providing information technology, systems integration and eSolutions to commercial and government customers.

The SDEIS/EIR and Draft Master Plan Addendum is available to the public for review in a variety of ways. Copies are available in 50 local and regional libraries, at the LAX Master Plan Public Reading Room located at the Imperial Terminal/Flight Path Learning Center at 6661 Imperial Highway and other locations across the region. The documents can also be viewed in their entirety on the Internet at [www.laxmasterplan.org](http://www.laxmasterplan.org) or purchased in various formats, including CD-ROM, by contacting Printco Graphics at (323) 727-6668.

Following the conclusion of the public comment period, the FAA, airport staff and its consultants will respond to comments and make any needed revisions based on the public input. The result will be a Final Environmental Impact Statement/Environmental Impact Report that will be forwarded to the Board of Airport Commissioners, the Los Angeles City Planning Commission, and then the Los Angeles City Council for review and action. Following City approvals, the plan will be forwarded to the FAA for coordination of final review and issuance of a Record of Decision. ■

# Ground Access

Airport traffic congestion is significantly reduced through new internal airport roads capable of handling passenger volume and expanded direct transit access, as well as proposed mitigation measures calling for direct freeway access.

Alternative D uses the area bounded by Aviation Boulevard, Arbor Vitae Street, La Cienega Boulevard and Imperial Highway as a comprehensive on-airport access area. This area would provide access to the new Ground Transportation Center and Intermodal Transportation Center, and add 36 lane-miles of new airport access roads to improve the flow of traffic.

Proposed mitigation measures would provide direct connection from the I-405 and I-105 Freeways with grade-separated roadways into the new internal airport roadway system.

The development of a Consolidated Rental Car Facility further reduces airport area traffic congestion. Each of these new ground access facilities would be connected to the airport terminal area by an Automated People Mover System. The automated people mover trains would operate to the Central Terminal Area from stations at each of the nodal points with an average 2-minute frequency.

### Ground Transportation Center (GTC)

The GTC is proposed as the pick-up and drop-off place for LAX travelers. It would replace the curbside drop-off area in the Central Terminal Area (CTA). The GTC would have eight separate 1400-foot-long curbsides connecting arrival and departing passengers to two separate and redundant people mover train stations. The curbsides would be identified through electronic signage designating airline and function. Curbside check-in would be available at the departing curbs for those needing or desiring this service.

Hourly structural parking would be available adjacent to the train stations to encourage greeters and well-wishers to stay with or meet passengers in the CTA. The GTC would also provide 7,500 structural parking spaces for long- and short-term use.

Airport security screening of passengers and baggage would be conducted at the GTC. The facility would be designed to accommodate security mechanisms such as limitations on the size and type of vehicles allowed at the curbs and in the parking garages, uniformed and plainclothes officers, canine patrol units, advanced technology devices and behavioral observation. The GTC would have the space and flexibility to normalize airport operations even while responding to heightened security needs.

### Intermodal Transportation Center (ITC)

The ITC would be the LAX connecting point for the Metro Rail Green Line light rail, regional transit buses, and future Metropolitan Transit Authority (MTA) rapid buses. The ITC would have a direct connection by a power walkway to the Green Line light rail station at Aviation Boulevard and Imperial Highway.

The ITC would also provide 9,100 structural parking spaces. An adjacent lot would offer 5,500 surface parking spaces. Structural parking would be for daily (less than seven days) business travelers and surface parking would likely be used by long-term and weekly travelers. The ITC

would be conveniently connected to the CTA by the airport Automated People Mover System.

The same airport security screening used in the GTC would also be employed at the ITC.

### Consolidated Rental Car Facility (RAC)

All on-airport rental car companies would have their facilities in a single, consolidated location. Ready and return structural spaces would abut a people mover station to facilitate easy roll-on or roll-off, non-stop service to the CTA. Rental car quick turnaround service areas, personnel offices, maintenance facilities and car storage lots would radiate from the ready and return spaces for maximum rental car company efficiency. The consolidation into one rental car center would facilitate directional signage for RAC customers to and from adjacent interstate highways and local streets.

The same airport security screening used in the GTC and ITC would also be employed at the RAC prior to passengers boarding the Automated People Mover System.

### Automated People Mover System (APM)

The new facilities would be built with People Mover Stations that service the CTA. Service would be available every 2 minutes with an average wait of just one minute. The APM would provide non-stop service from the GTC to the CTA in approximately 5 minutes. Service from the ITC to the CTA, with just one stop at the RAC, would be less than 8 minutes.

Each APM station would have two tracks and be designed in a flow-through manner, where by entering and exiting passengers use opposite sides of the car. The People Mover trains would be designed to easily and efficiently accept both roll-on luggage and baggage carts.

The APM would operate on elevated structures so as not to interfere with existing roadways.

**Legislative Update:** Ken Spiker, our legislative chairman and elected member to the Board of Administration of our Pension Fund, reports "not to worry" about a recent story and headline in the Los Angeles Times that read: "Underfunding of Pensions Could Exceed \$80 Billion."

Ken reports that the all-time high of our fund reached \$8.2 billion in 1999. A sluggish economy, falling stock prices and low interest rates lowered the fund to \$6.1 billion. However, changes in investment policies and the improved economy have increased the fund to \$7.1 billion.

He reports that our pension fund is fully funded and will cover all retirement obligations.

# LACERS Names Board President, VP for 2003-04

The Los Angeles City Employees' Retirement System Board of Administration (LACERS) has unanimously re-elected Shelley I. Smith as president and named Thomas J. Mizo as vice president. The seven-member board is responsible for establishing investment policy and the administration of retirement and health benefits for 24,000 active Los Angeles City employees and 13,800 retirees. Each member serves a five-year term. LACERS Fund assets are more than \$7 billion.

Ms. Smith has been an elected trustee of the system for more than nine years. She is assistant city attorney for the City of Los Angeles and is president of the Los Angeles City Attorneys Association. Ms. Smith also serves as chair of the Los Angeles Deferred Compensation Board, the City's voluntary defined contribution plan. Ms. Smith is a member of the Board of Directors of the Council of Institutional Investors and Treasurer of the Pacific Pension Institute. She also serves on the executive committee of the Labor & Employment Law Section of the Los Angeles County Bar Association.

Mr. Mizo is one of the three founding partners of Chadwick, Saylor & Co., a real estate investment banking/investment management firm in Los Angeles. He has primary responsibility for real estate funds marketing to tax-exempt institutional investors. His prior professional career includes eight years in real estate investment advisory organizations and seven years of law practice in Boston and Los Angeles. He has served on the board since September 2001.

## Warm Up Your October With Dips, Chilis, Soups and a Bewitching Brew

When I think of October and the rest of autumn, this is what comes to mind—and stomach: apples, cider, squash, hot soups, turkey, the savory sweet taste of pumpkin pie, bread and all those Halloween treats. It's also the time of year when the kids start spending a little more time indoors and need some activities and snacks to occupy their minds and hands.

Try out these fall theme recipes. Let's start with a recipe from Janine from Rec and Parks: a wonderfully flavorful **Creamy Spinach Soup**. She says that this was her way to get her kids to have green vegetables in their diets without them really paying attention to what is in the soup.

(By the way, does anyone know the history of chili? Allow me to share. It is said that the first recipes appeared in West Texas sometime



Most of the spices used in chili today were used then except for chili powder, which requires processing in a manufacturing plant, which had not been invented until decades later. Additionally, most of the chili then didn't have beans. Little did you know that you would be cooking and learning about the history of the food, right?)

Now that we are on the subject of easy recipes, the **Witch's Brew** is as easy to make as any beverage can be. You may substitute the club soda with sparkling water.

The **Spooky Hot Cheese Dip** is one of those dips that everyone loves anytime of the year. Why not as a Halloween appetizer? The **Spooky Hot Cheese Dip** is definitely an

appetizer most appropriate for a Halloween party. That's according to Maria, who works at the Department of Water and Power. She says that it will keep warm in a small crock pot if left on low heat. Maria knows what she is talking about: I have tried it and it makes high marks with me on the tasty scale. 🍴

### Witch's Brew

#### INGREDIENTS

- 3 pints grape juice
- 1 1/2 pints club soda
- Grapes
- Apples

#### DIRECTIONS

- Mix the grape juice and soda in a pitcher.
- Halve the grapes and take out the seeds.
- Cut the apple into small chunks.
- Float the fruit in the brew just before serving.



### Spooky Hot Cheese Dip

An easy and quick appetizer for your next Halloween party.

#### INGREDIENTS

- 1/2 cup medium or hot picante sauce.
- 8 ounces (2 cups) deli American cheese (you can substitute for another type of cheese), shredded.
- 1 (15 ounce) can black beans, rinsed, drained.
- 1 (4 ounce) can mild or hot chopped green chiles, drained.
- Tortilla chips.

#### DIRECTIONS

- Combine all ingredients except tortilla chips in 2-quart saucepan. Cook over low heat, stirring constantly, until cheese is melted (8 to 10 minutes).
- Serve warm with tortilla chips for dipping.

Makes 2 1/2 cups.

TIP: A small electric slow cooker makes a great serving container and keeps the dip warm. Keep it set on the low heat setting.



### Creamy Spinach Soup

A great way to sneak green vegetables into kids' diets is to purée them into a delicious, creamy soup. This one is light and thin. If you would like it thicker, add another potato and increase the salt to taste.

#### INGREDIENTS

- 1 8-ounce russet potato, peeled and cut into 1-inch cubes
- 1 quart organic vegetable broth
- 6 ounces baby spinach leaves
- 1/4 - 1/2 teaspoon salt, to taste
- Pepper to taste
- 1/2 cup half-and-half or milk

#### DIRECTIONS

- Place potato pieces in a medium-large saucepan and add 1-1/2 cups broth. Bring to a boil, lower heat to simmer, cover, and cook until pieces are tender, about 8 minutes. Add spinach and salt, stir, cover again, and cook about 3 minutes longer, or until spinach is wilted but still bright green.
- Transfer cooked mixture to a blender and purée until smooth. Add additional broth if necessary.
- Return mixture to pan, add remaining broth, and heat. When hot, remove from heat and stir in half-and-half or milk. Taste to adjust salt, and serve.

Serves 6 to 8



### Oh So Easy Chili

#### INGREDIENTS

- 1 pound ground beef or turkey
- 1 cup chopped onion
- 1/2 cup chopped green bell pepper
- 2 1/2 tablespoons chili powder
- 1 clove garlic, minced
- 1 bay leaf
- 1 jalapeno pepper, chopped
- 1 can tomatoes, chopped, undrained (28 ounces)
- 1 can tomato sauce (14 ounces)
- 1/2 teaspoon ground cumin
- 1 teaspoon paprika
- 1/2 teaspoon dried marjoram
- 1/2 teaspoon dried thyme
- 1 can chili beans or kidney beans, undrained (15 ounces)
- Salt and pepper to taste

#### DIRECTIONS

- Cook first 3 ingredients in a large saucepan until meat is browned, stirring until it crumbles; drain.
- Add chili powder and next 8 ingredients, stirring well; bring to a boil. Cover, reduce heat, and simmer, stirring occasionally, 1 hour and 30 minutes to 2 hours.
- Add beans, stirring well, and cook until thoroughly heated.
- Find and remove bay leaf before serving.

Serves 6
