#### New Column to Connect Club With City's Rich History

It is with great pride that I formally introduce you to the Los Angeles City Archives. This is the first of many articles relating interesting and historical information about our City government.

My name is Hynda L. Rudd. I became the first City Archivist in 1980; this was during the celebration of the City's bicentennial. My employment was with the City Clerk's Office. I was City Archivist from 1980-85.

I then became the Records Management Officer from 1986-2001. Within the scope of this time period, I began to realize that the City of Los Angeles had one of the finest municipal archival collections anywhere in this country. My disappointment has always been that this archival collection never received its full recognition. I hope these future articles will help to broaden the history of this incredible city.

Every month here in *Alive!*, I hope to share with you, fellow Club member, another historical aspect of our fine city, courtesy a record or two from the City Archives. I'm really looking forward to it.

The purpose of the City Archives' Historical Records Program is to identify, collect and preserve records of historical significance originated by City government. The City Archives represents the most unique and esteemed component of the City's Records Management Program. The City Archives wants to inform researchers not affiliated with the City government about the nature of the institution, and the resources that are available to the public. While a body of government records collectively known as the "City archives" has existed since the 1830s, the

City Archives as stated above was established in 1980.

Historically, the Los Angeles City Clerk's Office has assumed responsibility for keeping official City records and making them available to the public as well as to City officials and employees. This responsibility was outlined in the first City Charter of 1876, and continued in the Charters of 1889, 1925 and 2000. While the City Archives has records from as early as 1827, the great bulk of the records are from the 20th century.

They include records of the Los Angeles City Council Minutes; City Council Petitions and Files; past and current versions of the City Charter; Administrative and Municipal Codes; Contracts; Deeds to and from the City;

New Election Files (Precinct maps from 1908 to present);
Departmental Annual Reports; maps; photographs; financial reports and ledgers of the City Auditor, City Controller and Treasurer; and local

municipality records from

Eagle Rock, Hollywood, San Pedro, Tujunga, Venice, Watts and Wilmington prior to their becoming part of the City of Los Angeles. Also included are office files of Mayor Yorty, a little of Norris Poulson, and those of Richard Riordan. There are files of many of the Council Members from Tom Bradley and Art Snyder to the present. The staff of the City Archives has prepared finding aids and inventories that index the historical records of City Departments, City Council and Mayor.

Reference service is the top priority of the City Archives. Questions and comments regarding the program are welcomed, and the user is invited to make use of the resources for research purposes. The City Archives and the City Records Center are in the C. Erwin Piper Technical Center at 555 Ramirez Street, Space 320, Los Angeles, CA 90012. The facility is open Monday through Friday from 8 a.m. to 5 p.m. Contact Todd Gaydowski, City Records Management Officer at (213) 485-8783 or Jay Jones, acting City Archivist at (213) 485-3512 for further assistance.

the Club members who enjoy this newspaper.

"Los Angeles is very rich in history," Hynda continues. "I am not a native of Los Angeles; I come from Salt Lake City. I grew up thinking L.A. was La La Land. This is far from the truth.

"Once I became the City Archivist, and later the Records Management Officer, I realized the incredible depth and breadth of the records in the City Archives. The records follow the history of Los Angeles City government from the State's Act of Incorporation of 1850 through today. The City Archives has every City Council minute book and index from 1850 through 2004. The Archives contains the Mexican minutes (in Spanish with translations) from 1832 to the American occupation of 1847. Other records date back to 1828.

"This government history is so rich that I have become project director of a 26-chapter, 32-author anthology on the history of L.A. City government from 1850-2000. The two-volume work will be published in 2005."

Even her own journey toward becoming the City's archivist has its own story to tell.

"I became the City's first archivist because of a fateful encounter. I moved to L.A. from Salt Lake City in 1978. On July 5, 1979, I decided I needed to do some research on a man named Herman Silver, who I had written about for my Master's thesis in Salt Lake.

"Herman Silver was a 19th-century Abe Lincoln –type man who lived in Denver. My thesis covered the years 1826-1885. Silver was a prominent man in Denver. He was Assayer of the Mint in Colorado, as well as a lay-rabbi for the burgeoning Jewish community. I discovered in doing my research that Herman had moved to Los Angeles during the 1880s. I had heard that he eventually became the President of the City Council and ran for Mayor where he was defeated

"I wanted to know more about Mr. Silver. I decided on July 5, 1979, to go to the City Clerk's Office to do research. When I arrived, I was told to go upstairs in the City Clerk's vault in Room 320 City Hall. While doing my research, a man came upstairs and introduced himself as Bill Ashdown, Assistant City Clerk. It turned out he, too, had Utah roots. He asked me what I did professionally. I mentioned I had been an archivist and records manager. He told me that the City had prepared a federal grant to employ an archivist for an eight-month stint during the City's bicentennial. There was also the possibility that the City would eventually make the position

permanent. Mr. Ashdown suggested I apply when the grant became available, about November of 1979. I applied. I interviewed for the position along, with, I have been told, about 100 applicants. I eventually was fortunate to receive this esteemed position, which I held for five years. And that's how it happened.

"I was an employee of the City Clerk's Office for 21 years. I retired three years ago. These were the best working years that I experienced. I was fortunate to work in the profession of my choice, as an archivist and records manager. Also, I worked with a great community of diverse people within my immediate Office, as well as throughout City government and the general public. This City experience not only helped me understand the history of this unbelievable city, but broadened and matured me in the process.

"A sidebar to this story is about Herman Silver. In time after his mayoral defeat, he became the President of the City's first Water Commission. And the community of Silverlake is named after him."

The Los Angeles City Archives, under the City Clerk's office, is a treasure trove.

"The City Clerk's Office is one of the oldest departments in the rich history of Los Angeles City government," Hynda continues. "The evolution of this position was originally known as 'Council Secretary' dating back to 1850 under the State's Act of Incorporation. One of the City Clerk's major functions, dating back to the 1800s, was to maintain the records of City government. To me, this is one of the most important mandates of our city government.

Hynda feels that the City's Archives need to be celebrated. *Alive!* agrees.

"I am writing this monthly article because the L.A. City Archives will receive the recognition it deserves. I am the conduit to bring the documents to life in a City newspaper that is *Alive!* This publication affords City employees and retirees the opportunity to not only learn about the City's past, but to also understand they, too, commit history every day."

# New Day at LAWA

#### ■ Kim Day appointed executive director of Airports.

The Board of Airport Commissioners (BOAC) announced in late October the appointment

of Kim Day as executive director of Los Angeles World Airports (LAWA), the City department that operates Los Angeles International Airport (LAX) and three other airports.

Day had served as interim executive director since December 2003 following the resignation of Lydia Kennard. Day's appointment announced at a BOAC meeting following an extensive nationwide search and consideration of more than 100 candidates. Interviews of finalists were conducted by a panel of airport stakeholders and the BOAC.

The BOAC voted in closed session to appoint Day.

"The Board of Airport Commissioners is confident that it has made an excellent choice in selecting Kim Day to lead Los Angeles World Airports," said BOAC President Cheryl Petersen. "She is extremely well qualified to lead the department as demonstrated by her accomplishments over the past year as interim executive director."

Before being named interim executive director, Day served in the position of LAWA Deputy Executive Director of Project and Facilities Development since November 1999. She was responsible for design, construction and engineering projects at all four airports. She

was also charged with overseeing LAWA's Facilities Planning, Engineering, Residential Soundproofing, Construction & Maintenance and Space Planning Divisions.

Day is an architect with more than 25 years of experience in all phases of design and implementation, including substantial work on aviation projects. She began her professional career in 1977 with Daniel, Mann, Johnson and Mendenhall (DMJM) of Los Angeles/San Francisco. As a DMJM vice president, Day oversaw a variety of airport and transportation projects,

including serving as project director for the Ontario International Airport Terminal Project.

Day earned her Bachelor of architecture degree from Cornell University in 1977, and has completed graduate course work for the Haas School of Business at the University of California, Berkeley. She is a member of the American Institute of Architects.

In accordance with City Charter, the appointment was subject to confirmation by the Mayor and City Council.

# LAX Plan Nearing Liftoff?

#### **■** Council approves consensus plan for major LAX rebuild, but obstacles may be placed in its way.

ec. 7, the City Council approved Mayor Jim Hahn's controversial plan to rebuild Los Angeles International Airport. But expected lawsuits by other governments and neighborhood groups could challenge the plan's ultimate and complete implementation. The final version of the plan was developed by consensus with the Council.

Mayor Jim Hahn applauded the City Council for voting to move forward with the plan to modernize LAX. Mayor Hahn was joined by members of the business, labor, environmental and residential communities today at City Hall to celebrate final override of a County land-use comground transportation center located east of the current passenger terminal area; northern runway improvements; demolishing Terminals 1, 2, 3 and the north end of the Tom Bradley International Terminal; and construction of a new western ter-

"The long-awaited modernization of L.A.'s international air gateway is finally at hand," said LAWA Executive Director Kim Day. "Upon receiving final federal approval early next year [2005], we will be ready to embark on a full decade of construction projects and community mitigation measures that will benefit all LAX stakeholders and the Southern California econo-

Approval of the Consensus Plan also enables the City to move forward with an historic agreement between the City of Los Angeles, LAWA and the LAX Coalition for Economic, Environmental and Educational Justice, which includes more than 20 community groups, envi-

mission opposed to the plan, the final certification of the LAX Master Plan Environmental Impact Report (EIR), and the adoption of the Consensus Plan.

"Today the City of Los Angeles demonstrated a shared commitment to creating a safer, more secure airport," the mayor said. "My primary interest in improving the airport is to increase the security of LAX's employees, travelers and infrastructure. This plan will enhance the safety of the millions of passengers who move through the airport every year."

As a result of the attacks of Sept. 11, 2001, Mayor Hahn directed Los Angeles World Airports (LAWA) to develop a new alternative to airport modernization that focused on safety and security, which resulted in the LAX Master Plan Alternative D, the Enhanced Safety and Security Alternative.

The Consensus Plan, developed by Mayor Hahn and City Councilmember Cindy Miscikowski, is a process for airport modernization that would allow LAWA to move forward on elements of the LAX Master Plan Alternative D that enjoy the support of many stakeholders. These elements include realignment of the southside airfield, a new consolidated rental car facility, a new intermodal transportation center that links to regional transit, an automated people mover, and an expansion of the FlyAway pro-

"The City Council today indicated that they were ready to begin the process of modernizing LAX to both meet the needs of the aviation industry and balance the concerns of the surrounding communities," said Councilmember Miscikowski. "The LAX Master Plan will provide for the safety, security and convenience to the traveling public. Meanwhile, the Master Plan, the Stakeholder Liaison and the new Community Benefits Agreement will allow local communities to have a real voice in mitigating the impacts of daily flight operations."

The Consensus Plan would also require additional studies involving vehicular traffic impacts, aviation activity and security issues before "yellow-lighted" elements of Alternative D were implemented. These elements include a new

ronmental organizations, school districts and labor unions.

At more than \$500 million, the Community Benefits Agreement (CBA) represents the largest and most comprehensive CBA ever negotiated.

"Last year I directed LAWA staff and my own staff to work with the coalition to negotiate an agreement that would provide environmental, economic and educational benefits to the most impacted communities surrounding the airport," said Mayor Hahn. "This Community Benefits Agreement is a national model for airport development and serves to enhance the quality of life for those living around the airport. In the spirit of cooperation and trust, together we have developed a comprehensive plan of which we can all be

Some of those benefits include:

- Increased funding for the soundproofing of homes and all affected schools;
- Retrofitting diesel construction vehicles and other diesel vehicles operating on the tarmac to curb dangerous air pollutants by up to 90
- Electrifying airplane gates to eliminate pollution from jet engine idling;
- Studying the health impacts of airport operations on surrounding communities and making those studies public on the LAWA Website;
- \$15 million in job training funds for airport and aviation-related jobs;
- Creating a local hiring program to give priority to local residents, low-income and special needs individuals for new LAX jobs; and
- Enhanced opportunities for local, minority and women-owned businesses in the moderniza-

The last comprehensive update of LAX was completed in 1956, and the last major upgrades to terminals and airport roads were completed before the 1984 Olympics.





It is notable that the fund has recovered from the losses that occurred in 2001 and 2002. Ken gives the LACERS staff, especially Dan Gallagher, the

credit for the recovery and excellent investment

The LACERS Board of Directors has unanimously approved a proposal offering the City a 15 year payback plan for the \$43 million the City owes the retirement fund. If approved by the City Council and Mayor, the plan will become effective on July 1, 2005, and carry an 8 percent annual interest rate.

Ken also reports that the Board of Directors has approved an increase in the monthly Medicare Part B reimbursement from \$66.60 to \$78.20. The increase became effective Jan. 1 and will match the announced 17 percent rate increase of the Federal Medicare Program.



# Make Sure to Pack A Sense

Thought it might be fun to share with Lyou some personal adventures I've experienced while traveling the world.

My wife and I took our kids to a top resort in Hawaii when our oldest child was only five. We did millions of dollars in business with the particular hotel and its parent company, but we were greeted by a desk agent with an attitude. The connecting oceanfront rooms we were promised were not available for us. We were told that our children could be in one wing and my wife and I could be in another wing, about a ten-minute walk away. This desk clerk was serious! When I asked for the manager, the same clerk did a 360-degree turn and advised me that she was the acting manager that evening. We ended up sharing a garden room with roll-aways that night. I was able to reach the president of the hotel chain the next morning, and our rooms were changed along with a big apology. Nevertheless, there was absolutely nothing I could have done to resolve the situation the night before. We were VIPs and treated like that! We now have much more empathy for what our clients occasionally go through, even at the best properties. arrived, the ship had just departed. We made arrangements with the port agent to take a taxi to Virginia Beach, board a launch boat and meet the ship on the open seas. (This misadventure required a stop at an ATM so I could pay the launch operator \$400.) A rope ladder was thrown overboard and we actually had to climb aboard the ship while it was moving. Not only was it scary, but the embarrassment was overwhelming. Hundreds of passengers were taking pictures and videos as we made our way up the ropes. 



#### Newsbrief

#### **FINAL TUNNELING:**

Councilmember Ed P. Reyes announced Nov. 15 that the final tunneling stage of the \$160 million Northeast Interceptor Sewer Project has begun and the entire project will be completed this summer.

"Our children were dangerously playing in untreated sewage that spilled onto City streets during the El Niño rains in the late 1990s," said Reyes, who helped secure the funding for the NEIS Project. "The NEIS Project is necessary to handle the wastewater flow, and to protect the safety and health of our communities." Reyes' announcement followed a gathering at the shaft site at Humboldt Street and San Fernando Road where Bureau of Engineering staff showed off the "Ground Hog," the tunnel-boring machine which drilled 135 feet underground for the final construction phase of the NEIS Project. The NEIS Project is an 8-to 11-feet in diameter tunnel that extends 6 miles from the intersection of Mission Road and Jesse Street near 7th Street in eastern downtown, northward to the intersection of San Fernando Road and Eagle Rock Boulevard. The NEIS Project, along with the Eagle Rock Interceptor Sewer (ERIS), will relieve the decaying North Outfall Sewer (NOS) which was built between 1924 and 1930. The NOS has been strained by structural defects resulting from corrosion and population growth.

The El Niño storms of 1997-98 caused a number of sewer overflows and required the construction of new sewers to provide additional capacity. On Sept. 14, 1998, the Los Angeles Regional Water Quality Control Board ordered the City to take action to prevent future overflows. The City's Bureau of Engineering and its consultants developed NEIS and ERIS to provide the additional capacity needed to comply with the order and allow for the rehabilitation of the existing sewer. Construction of NEIS began in July

"Our residents have been extremely patient," Reyes said. "They know how important it is to protect the health of our children, and make sure that the El Niño overflows never happen again."



Ruby, the 43-year-old African elephant who was transferred to the Knoxville Zoo in May 2003, returned to the Los Angeles Zoo and Botanical Gardens Nov. 13. The transport truck arrived at the Zoo at 10:30 p.m. and Ruby stepped off the truck and walked into her off-exhibit barn. She immediately started munching apples and bananas.

"I am pleased to announce that Ruby arrived safely and is settling in very well," Mayor Jim Hahn said.

The 40-hour cross-country drive went smoothly, according to the Zoo. Planned Migration, the animal transport company that handled Ruby's trip to Knoxville, conducted the return trip. Prior to the move, the L.A. Zoo elephant curator, principal elephant keeper and a Zoo veterinarian flew to Knoxville to assist in the move and to follow the truck to Los Angeles. The trip was non-stop with the exception of periodic breaks for Ruby and the people accompanying her.

Ruby was originally transferred to the Knoxville Zoo to integrate her with a herd of African elephants to contribute to the longterm propagation of African elephants in North American zoos.

"Since Ruby has been away from the L.A. Zoo elephants for more than a year, the staff who care for our elephants will accept Ruby as a new elephant entering the collection. We are currently revisiting present and future plans for all of the Zoo's elephants."

City Councilman Tom LaBonge, who represents the Zoo, added, "The most important thing is that the Zoo do what's right for the animals. I support the Zoo in moving Ruby to Knoxville and in bringing her back to Los

A new elephant habitat is under construction at the L. A. Zoo. Prior to the decision to move Ruby to Knoxville, an off-exhibit area covering 8,300 square feet was renovated to accommodate the Zoo's three female elephants. Between that space and the former area, which is still available during construction, there is more than ample room for all four of the Zoo's elephants—Billy, Tara, Gita and Ruby.

Ruby was to be guarantined for 30 days in the off-exhibit elephant compound. She will be sharing space with Tara, a 44-year-old African elephant. Gita and Billy will be on public exhibit in the elephant area in the main Zoo.

# Dog Disease Outbreak The Pet

#### ■ City, County declare an outbreak of distemper. Humans not affected.

.A. Animal Services and L.A. County's L.A. Animar Services and Veterinary Public Health Office declared a distemper outbreak in Los Angeles Dec. 2 with both agencies recommending distemper vaccinations for all dogs.

In his report, Veterinary Public Health and Rabies Control Chief, Dr. Patrick Ryan, wrote: "We see periodic outbreaks of canine distemper in dogs and wildlife, such as raccoons. Animal Shelters often experience outbreaks in unvaccinated dogs and puppies. What is occurring in the shelters generally mirrors what is happening in the community."


Canine distemper is a highly contagious, systemic, worldwide, viral disease of domestic dogs and susceptible wildlife. It is caused by a virus closely related to the measles virus and is transmitted through the air (airborne) or through droplet exposure from the nasal cavity, pharynx and lungs. It cannot be transmitted from animals to humans.

"Distemper can be very dramatic in its presentation causing respiratory, gastrointestinal and neurological symptoms," says L.A. Animal Services Chief Veterinarian, Dr. Casandria Smith. "The course of the disease can be days to weeks characterized by fever, nasal and ocular discharge, depression, anorexia, convulsions, seizures and death. It is physically devastating to the animal and emotionally devastating to animal guardians."

Other animals susceptible to distemper include wildlife including raccoons, coyotes, foxes, wolves, ferrets, skunks, mink, leopards, lions and tigers.

L.A. Animal Services reminds pet owners to check with their private veterinarians on a regular basis for advice on preventive medicine as well as for guidance on infectious diseases.

I knew I wanted to adopt a shelter animal. Buying one from a breeder or pet store was (1) way too expensive and (2) just plain nuts considering all the wonderful homeless animals begging for a home.

I kept looking on our L.A. Animal Services Website until I found what appeared to be a pathetic dirty white poodle. It had problems fleas and stuff like that. Okay. I went to the shelter maybe five or six times to visit this poor thing. He couldn't even look at me through that tangled mess of fur that he dragged around. I felt so bad for this mess-of-a dog yet it felt so right. In the end, I adopted him.

Here was the problem: My daughter, Nikki, wanted a "girl" sheep dog. This dog was a male. Okay, neutered, but still a male. I solved the dilemma by naming this dog Tootsie - you know, as in the Dustin Hoffman movie Tootsie. My son, Stephen, didn't like the name, but Mommy made the decision and that was it.

Looking at Tootsie today, you would swear this is not the same animal. I got him vet care, did some wonderful grooming, and guess what I found under that tangled mess? A most beautiful pure breed Barbichon Frise - a lily-white fur ball, with a cute red tongue that hangs out of his mouth and a tail that wags to no end. He loves us fiercely and he also believes he is

real well

and I know I've done the right thing for my Nikki, Stephen and Tootsie. They watch TV with Toots and lie down and cuddle with him and play with him and just enjoy him to no end. Some very serious bonding has happened. Tootsie has become family and we do not discard our family members.

You should see how proud my kids are of Tootsie. People who see him always comment as to what a beautiful animal he is. They have trouble believing that this model-perfect creature was a shelter dog - one of society's discards. How could anyone possibly treat him like garbage and toss him out into the street?

I've since adopted another -- a girl dog named Mimi, also a shelter dog who now gets the ultimate royal treatment. She too was a mess and now looks like one giant pampered fur ball. Some ugly people used her for breeding and when they were done with her, tossed her out into the street. She now has a loving home

I've also added Snowy to the bunch – that's the final one since we're not allowed to own more than three dogs in the City of Los Angeles. Snowy is a little dumb and we love her just the same.

We call all three dogs our three stooges. We have fun. They have fun. We take care of each other. We love each other. We are family and my daughter no longer thinks she's a dog or cat.

So, what do you say? There's a pet out there waiting for you – the perfect animal – that can enrich your life the way our animals have enriched our lives. Think about what kind of pet would work best for you and your family and then begin the process: start looking until you find your true love that will love you back unconditionally.

There is much loneliness in this world and it doesn't have to be that way when there are those waiting to provide us with loving companionship. We have them here, at our shelters, waiting for you. I guarantee, you won't be disappointed and, if you have kids, it will teach them how to care for and love all God's creatures. It's what life is all about.



#### **WEST L.A. TRAFFIC:**

Responding to concerns about traffic congestion and unsafe conditions in the West Los Angeles area of his district, Councilmember Jack Weiss on Dec. 8 introduced a measure to create a West Los Angeles Regional Traffic Task Force to review traffic studies and recommend the best use of available traffic mitigation funds.

"Traffic is the top quality of life concern in the West Los Angeles area of my district," said Weiss. "Motorists, pedestrians, residents, and local businesses are frustrated by unsafe driving, cut through routes in residential neighborhoods, gridlock, and delays."

Recently concerns have been raised about the impact of the Century City Neighborhood Traffic Management Plan (NMTP). The NMTP was designed to improve traffic flow on main arteries and discourage use of smaller residential streets. Improvements and mitigations in the plan are funded by revenues from development projects in

the area, and some additional mitigation funds will be available for future traffic projects. Weiss' measure will establish a Council District 5 (CD5) Regional Traffic Task Force that will include representatives of neighborhood councils and other neighborhood organizations in the West Los Angeles area of his district. The Task Force will coordinate with the existing and planned traffic studies of other organizations within the area to evaluate plans, and develop recommendations for improving traffic conditions in the area.

It will be responsible to advise the City Council of the best possible use of available funds for improvements and mitigation and provide regular updates and recommendations directly to the City Council's Transportation Committee. The measure will be discussed by the Transportation Committee in the new year.

#### **EXCELLENT FINANCIAL REPORTING:**

When you look at the corporate scandals that have occurred in America, I am proud that the City of Los Angeles stands as a model of responsibility, accountability and accuracy for others to follow."

The GFOA is a nonprofit professional association serving approximately 14,000 government finance professionals.

#### **HOMELAND SECURITY**

Mayor Jim Hahn announced Dec. 3 that the Los Angeles Urban Area, which consists of 16 cities and the county, will receive



\$61 million in homeland security funds in the latest round of Urban Area Security Initiative (UASI) funding from the United States Department of Homeland Security - Los Angeles' largest award under the UASI program

"The City of Los Angeles has spent over \$150 million for enhanced security, new equipment and training for first responders since September 11, 2001. Urban Area funding helps to further prepare our city and our neighboring cities, to ensure that we meet the challenges of protecting our region in the event of an emergency," said

Administered by the Department of Homeland Security, UASI offers financial assistance to address the equipment, training, planning, exercise and operational needs of large, high threat urban areas. The grant enhances Los Angeles' capacity to prevent, respond to, and recover from threats or acts of terrorism by helping to establish regional response teams, reim-


bursing cities for costs related to orange alert, and enhancing emergency operations centers in urban area cities.

This is the fourth round of Urban Area funding to Los Angeles. In the last three rounds Los Angeles received \$60 million total; in this fourth round of funding the Department of Homeland Security has doubled Los Angeles' award. Los Angeles received the third highest allocation behind New York City (\$207 million) and Washington D.C. (\$77 million).

"I am thrilled that critical funding has been awarded to our city for badly needed equipment and terrorist-response training for our police officers and firefighters," said Congresswoman Lucille Roybal-Allard, who sits on the Homeland Security Subcommittee of Appropriations. "The increased funding for urban area grants represents a heightened recognition by my colleagues of the importance of distributing homeland security funds to areas with the greatest need, such as the Los Angeles region, which is home to Los Angeles International Airport and our nation's largest container port, the Los Angeles/Long Beach Port Complex."

The Los Angeles Urban Area was designated for funds based on a combination of factors including population density, critical infrastructure and threat/vulnerability assessment. The L.A. Urban Area is made up of the City and County of Los Angeles and 16 contiguous cities including: Alhambra, Beverly Hills, Burbank, Commerce, Culver City, El Segundo, Glendale, Hawthorne, Inglewood, Monterey Park, Pasadena, San Fernando, Santa Monica, Torrance, Vernon and West Hollywood.

"The sheer size and assets of the City of Los Angeles make us especially vulnerable to terrorist attack and challenge our security infrastructure and resources. We know that local responders will be first on the scene to respond to any emergency in our city, which is why we must provide the Los Angeles Police and Fire Departments with all of the resources necessary to protect the residents of this city," said Mayor Hahn.

struction of our Fallen Firefighters Memorial," said Society Director Frank Borden. "It is deafening but it is a great sound to hear."

The Historical Society's Board of Directors met Nov. 20 and made a very important decision to begin construction on the LAFD Fallen Firefighters Memorial. This is a major milestone in the project. Construction will take place in phases, only building what we can afford. "We will use nearly all the money we have in the bank currently for phase one. Our general contractor is John Rotondi," Borden said.

The project is beginning to take shape at the restored Fire Station 27, at 1355 N. Cahuenga Blvd. in Hollywood, the home of the LAFD Fire Museum and the Society headquarters.

"We noticed that Los Angeles is one of the few major cities without a firefighters memorial," said Liz Bamattre, chairperson of the Memorial Committee. "There is a war veterans memorial, that contains those firefighters who died serving their country. But no memorial for those who died serving their city."

The project has been developing for some

time. The Historical Society organized a design contest. Five entries were received, and the winning design came from LAFD (active) Captain Dwayne Golden.

Liz Bamattre explains. "It's five bronze statues, of firefighters doing what they do, fighting fires and saving lives," says Liz Bamattre, chairperson of the Memorial Committee. "It's not contemporary. It's very realistic and practical, which we thought was appropriate. It's poignant.

"I've seen many memorials. But our statues really bring into the memorial the department's everyday emergency abilities, an emergency medicine element. Emergency medicine is so much of what the department does.

"The design really reflects what the department does every day."

The design selected, the Historical Society took the plans to Honors for Excellence, a Minnesota company that specializes in creating such memorials. "Building our statues was a labor of love for them as much as it was for us," she says.

The statues were delivered in early 2003. Now under construction is a place to put them: "There's an outdoor plaza outside old Fire Station 27 that we thought would be beautiful," she says. And thus it was chosen. The society selected Los Angeles architect Michael Rotondi of Roto Architects to create the plaza.

The Memorial Wall itself, which will hold the names of those fallen in the line of duty, was designed by Los Angeles artist Yoshikawa. The wall will contain an archway of limestone, water that streams down the surface, and etched glass.

The Historical Society has launched a brick memorial program, where anyone can contribute to the project and have their name etched permanently on the patio's brick pavers.



The LAPD graduated its 2004 recruit class of new Detention Officers in a ceremony Nov. 24 at the Elysian Park Police Academy Gymnasium.

Principal Detention Officer David C. Yen provided these details: The Detention Officers (DO) staff the LAPD's three regional jails and seven area jails. One of the area jails is in Wilshire area.

The recruit Academy course is nine-and-a-half weeks long. LAPD operates the largest Type I jail system in the western United States. A Type I facility is the classification for jails that process and house pre-arraignment arrestees. Our Department adheres to the guidelines that Board of Corrections has set forth for the correctional system. Per Board of Corrections, our recruits are required to attend a minimum of 176 hours of training.

The recruits have had extensive training in Codes, Statutes and Legal Documents; Professionalism and Ethics, Cultural Diversity; 832 PC Arrest and Control Training and Contraband and Evidence. They additionally gained practical training in Tactical Communications, the LAPD Arrest and Control Defensive Tactics Course and First Aid and CPR. The Academy is run by the detention personnel assigned to LAPD Jail Division, Standards and Training for Corrections (STC) Unit.

Twenty-eight recruits planned to graduate. On an average, there are two classes of detention officer recruits a year. Captain II Patrick K. Findley is the current Commanding Officer of Iail Division.







■ Captain II Robert Knight, who transferred from the field to the Fire Prevention Bureau. He is in charge of the high-rise unit.



Perishable foods such as lunch meats, cooked beef or chicken, tuna, potato, egg and pasta salads all need to be refrigerated. I highly recommend that you use watertight containers to prevent

Be prepared to wash your hands frequently, especially when handling protein like poultry and raw beef.

When the party is over, you may have leftovers. The following tips are great for handling leftovers: Refrigerate leftovers as soon as you can because food that sits out for more than two hours isn't safe to eat. If the ambient temperature is above 90 degrees, food should be put up after one hour.


# Marino's Grilled Butter Oysters

# Running Back Jalapeños


#### **INGREDIENTS**

- 1/4 lb ground beef
- 10-12 popper-size jalapeños • 1 small onion
- 1 lb bacon
- 12 oz 1 lb. Monterey Jack w/jalapeños cheese

#### DIRECTIONS

Chop onion and brown in small amount of oil. Add hamburger and brown and drain. Grate cheese and mix with hamburger. Cut top off jalapeños and core out the seeds. Slit

down to 1/4 inch from bottom. Stuff with hamburger mixture. Wrap slice of bacon around popper. Stick with toothpick if necessary. Grill over coals until done.





#### **INGREDIENTS**

- 2 California avocados, about 1 pound
- 1 tablespoon fresh lemon juice
- 1/2 cup small cherry tomatoes
- 1/4 cup thinly sliced green onion
- 3 cloves garlic, finely chopped
- 1/2 teaspoon chopped, fresh thyme leaves or 1/4 rounded teaspoon dried
- 1/2 teaspoon sea salt
- 1/4 teaspoon freshly ground black pepper
- 1/8 teaspoon cayenne pepper

Coarsely mash avocados; stir in lemon juice. Fold in remaining ingredients. Guacamole is best made as close to serving as possible. For short-term storage, seal in an airtight container with a piece of plastic wrap against the surface of the guacamole, and one avocado seed.




